This will respond to your communication to this Office on April 15, 2013, and the voice mail message left with Office staff on September 10, 2013, regarding a potential crime you sought to bring to the attention of this Office. If we determine that a Civilian Crime Report we receive raises a matter within the jurisdiction of this Office that should be investigated further and that additional information from you is necessary for our investigation, an agent would contact you. Other than in exceptional situations, we neither confirm nor deny the existence of an investigation unless and until charges are publicly filed. Even as to persons who may have reported a possible crime to our Office (and/or believe themselves to be a victim of *an uncharged crime*), we do not provide updates regarding any action that may have been taken on their report unless there is an investigative or other specific reason to communicate with them. Nevertheless, please be assured that this Office takes all allegations of criminal conduct very seriously and carefully reviews any investigative evidence presented to support such allegations in determining whether further investigation by this Office is appropriate. **This Office does not resolve individual consumer complaints.**

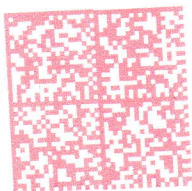
