This follows up my phone conversation on Friday, June 28, 2013, with Investigator Jack Patterson, in connection with the June 27, 2013 ethics complaint we filed with the New York State Joint Commission on Public Ethics against New York State's highest constitutional officers, public officers, and employees of the executive and legislative branches of NYS government.

I stated to Mr. Patterson that voluminous documentary evidence substantiating our June 27<sup>th</sup> ethics complaint had been furnished, years ago, to the New York State Ethics Commission. Such documentary evidence substantiated a succession of ethics complaints we had filed with the State Ethics Commission beginning, in 1992, with our ethics complaint against the New York State Board of Elections and, in 1995, against the New York State Commission on Judicial Conduct and New York State Attorney General, including a request for intervention in our Article 78 proceeding *Doris L. Sassower v. Commission on Judicial Conduct* (NY Co. #95-109141), which, in 1999, we supplemented, including by a request for the Ethics Commission's intervention in our *Article 78 proceeding: Elena Ruth Sassower, Director of the Center for Judicial Accountability, Inc, acting pro bono public, v Commission on Judicial Conduct of the State of New York* (NY Co. #99-108551).

As such documentary evidence is relevant to our June 27<sup>th</sup> ethics complaint to the Joint Commission on Public Ethics – as well as relevant to the investigations that will be undertaken by Governor Cuomo's Moreland Commission to Investigate Public Corruption, including with respect to its express mandate to examine "the Board of Elections' enforcement, and the effectiveness of and compliance with existing election laws" – kindly advise what became of the records of the New York State Ethics Commission upon its dissolution.

For your convenience, our own "paper trail" of these prior ethics complaints and the mountain of substantiating documentary proof that we furnished to the Ethics Commission, spanning from February 5, 1992 to September 22, 2003, is posted on our website, <a href="www.judgewatch.org">www.judgewatch.org</a>, accessible via the left sidebar panel "Searching for Champions-NYS". Indeed, here's the direct link to our <a href="CJA's September 23, 2003 letter to the Ethics Commission">Commission</a>, as it is entitled: "(1)Preservation of the records of CJA's ethics complaints..." – and itself identifies that among the substantiating case files we furnished were those of our two Election Law lawsuits: Castracan v. Colavita and Sady v. Murphy, and our two Article 78 proceedings against the Commission on Judicial Conduct.
