Note: The Assembly wants to pass the Woman's Equality Act in its original form allowing for all 10 points listed below. The Senate members would not until the leadership removed the 10th point that protects a woman's Freedom of Choice.

The Women's Equality Act will:

- 1 Achieve Pay Equity
- 2 Stop Sexual Harassment in All Workplaces
- 3 Allow for the Recovery of Attorneys' Fees in Employment and Credit and Lending Case
- 4 Strengthen Human Trafficking Laws
- 5 End Family Status Discrimination
- 6 Stop Source-of-Income Discrimination
- 7 Stop Housing Discrimination for Victims of Domestic Violence
- 8 Stop Pregnancy Discrimination Once and For All
- 9 Protect Victims of Domestic Violence by Strengthening Order-of-Protection Law
- 10 Protect a Woman's Freedom of Choice
