Our nonpartisan, nonprofit citizens' organization asked that question – <u>three weeks ago</u> – in an August 5th letter to its Executive Director, Regina Calcaterra, which we also sent to its three Co-Chairs, D.A. William Fitzpatrick, D.A. Kathleen Rice, and Milton Williams, Jr.

The letter additionally asked how the Commission handles the "TIPS" and "COMMENTS" it receives from members of the public reporting public corruption, by phone and *via* its website – and the protocol for the Commission's upcoming public hearings, whose notice does <u>not</u> request any advance registration or RSVP.

We have received no response.
