Dear Meghan,

I did not see this e-mail previously. I apologize. When would Senator Murphy be available? -- and did he want to arrange the meeting with Ranking Member Hoylman, as well -- or with Senator Marchione, who was present when I testified at the Legislature's January 30th budget hearing and who chairs the Senate Committee on Local Government, of which Senator Murphy is a member, and whose jurisdiction includes D.A. salary reimbursement to the counties -- the subject of the 10th cause of action of the September 2, 2016 verified complaint in CJA's citizen-taxpayer action.

As reflected by my January 30th testimony, time is at a premium here. The constitutional, statutory, and legislative rule violations of prior budget cycles are repeating. Attached is my yesterday's letter to Temporary Senate President Flanagan, Minority Member Stewart-Cousins, etc. -- to which Senator Murphy is an indicated recipient. This follows up my phone message last week – and my phone conversation earlier today with the Senator's legislative director & counsel, Morgan Maragliano, concerning the Senate Committee on Investigations & Government Operations, which the Senator now chairs. The Committee has important "government operations" to be investigating — beginning with operations of the Legislature and its uncertified/slush-fund budget which fails to itemize the "financial needs" of any of its 34 Senate standing committees or 38 Assembly standing committees, excepting the Assembly Ways and Means Committee (& Senate Finance Committee) – thereby concealing that they have no funding and staff to discharge their constitutional responsibilities, which they do not remotely fulfil. The unconstitutionality, unlawfulness, and fraud of the Legislative budget, as likewise of the Judiciary budget – and the Executive budget – and the mass of corruption this has enabled – is chronicled by two citizen-taxpayer actions brought by our non-partisan, non-profit citizens' organization – the second of which is unfolding now in Albany Supreme Court. The record of each is posted on CJA's website, www.judgewatch.org, accessible *via* the prominent homepage link: "CJA's two citizen-taxpayer actions to end NY's corrupt budget 'process' and unconstitutional 'three men in a room' governance".

I am requesting that Senator Murphy, as chair of the Senate Committee on Investigations & Government Operations, PERSONALLY review the unfolding second citizen-taxpayer action – and put it on the agenda of the Committee for discussion by the members – and a vote as to the multitude of investigations that must be authorized based thereon. To that end, I am requesting a meeting with Senator Murphy – much as I have requested a meeting with the Committee's long-standing ranking member – Senator Hoylman – who, this year, has additionally been appointed as ranking member of the Senate Judiciary Committee.

Attached is the meeting request form that I filled out and sent yesterday to Assemblyman Hoylman's scheduler by the below e-mail, attaching, as well, the meeting request form I had completed and e-mailed last week to meet with Senate Judiciary Committee Chairman Bonacic.
