- (2) all records reflecting "review" of the report by JCOPE's commissioners, including at any of their meetings especially as JCOPE's 2015 Annual Report to the Governor and Legislature, dated April 7, 2016, does not appear to mention "the New York Ethics Review Commission", its report, or review of its "findings and recommendations" by the JCOPE commissioners;

- (3) all records reflecting any <u>hearings</u> by the Legislature on the misnomered "New York Ethics Review Commission" report and, particularly by any of the most pertinent Senate and Assembly committees, *to wit*,
 - the Senate Ethics Committee;
 - the Assembly Committee on Ethics and Guidance;
 - the Senate Committee on Investigations and Government Operations;
 - the Assembly Committee on Governmental Operations;
 - the Assembly Committee on Oversight, Analysis & Investigation.
- (4) all records reflecting that these legislative committees ever placed the "New York Ethics Review Commission" report on the agenda of any of its committee meetings for review and discussion:
- (5) All records pertaining to the whereabouts of the records of the "New York Ethics Review Commission", including the video of its one and only hearing, on October 14, 2015, in Manhattan at which I testified and any transcription thereof and pertaining to the evaporation of its website, www.nyethicsreview.org, at some unknown date following issuance of its report.
