Dear Mr. McCarthy,

Following up our brief telephone conversation at 1:30 this afternoon, attached is CJA's August 28th coversheet to you and Editorial Page Editor Stephen Bell, transmitting (by fax & e-mail) CJA's August 25th memo -- which you stated you knew nothing about.

As a member of the panel questioning the gubernatorial candidates at tomorrow evening's debate in Buffalo, you have a unique opportunity to <u>transform the political landscape</u> by your questioning of Mr. Spitzer and Mr. Faso, based on CJA's June 26, 2006 letter to Mr. Faso. That letter, with its certified mail/rrr, fax-and e-mail receipts establishing transmittal to Mr. Faso's campaign headquarters, is posted on CJA's website, <u>www.judgwatch.org</u>, accessible *via* the sidebar panel "Elections 2006: Informing the Voters". For your convenience, these are attached.

The June 26th letter is an election-altering, primary-source document, reflecting on Mr. Faso's unfitness by his failure to respond to it. This, because the letter set forth the <u>documentary evidence</u> of Mr. Spitzer's corruption in office as attorney general -- virtually all posted on our website. Indeed, our "Elections 2006" webpage has two links that will take you directly to this documentary evidence. These are "Press Protectionism of A.G. Spitzer" and "Paper Trail of A.G. Spitzer's Corruption in Office."

Just as we offered Mr. Faso hard copies of this evidence so that he could more easily verify that it is not only dispositive of Mr. Spitzer's unfitness for any office of public trust, but <u>requires that he be criminally</u> <u>prosecuted for corruption</u>, we also offer hard copies to you. I would point out that from 1999 onward we filed fact-specific, fully-documented ethics and criminal complaints against Mr. Spitzer with the New York State Ethics Commission and the U.S. Attorney for the Eastern District of New York, which have not been dismised and <u>remain pending</u>.

I would be pleased to review with you CJA's June 26, 2006 letter, the referred-to documentary evidence, and to assist you in developing appropriate questions for BOTH Mr. Spitzer and Mr. Faso based thereon. Call me anytime today or tomorrow and I will "drop everything" to do so.
