Dear Mr. Patience,

This responds to your totally mixed-up e-mail of today's date, which is **NON-RESPONSIVE** to any FOIL request addressed to you or Senate leaders.

The July 18, 2013 e-mail to which you are purporting to respond is below.

It does NOT state "this request supersedes the request dated July 16, 2013". Nor does it ask you or Senate leaders to respond to a FOIL request to the Governor, which is what you have done.

Rather, it attaches a July 18, 2013 FOIL request addressed to you and Senate leaders for five categories of records pertaining to the Senate's receipt and handling of the Governor's Program Bills #4, #5, and #6. Where is your response? And is it on behalf of the Democratic Conference Leader, in addition to the Majority Coalition Leaders?

Attached is that same July 18, 2013 FOIL request addressed to you and Senate leaders. Kindly respond without delay.

Further, where is your response to our July 16, 2013 FOIL request addressed to you and Senate Leaders for six categories of records pertaining to the Senate's receipt and handling of the Governor's Program Bill #3 – the Public Trust Act. It was sent by e-mail on July 16, 2013. Did you not receive it?

In the event you did not, that same July 16, 2013 FOIL request is attached. Please also respond to it without delay – and also indicate whether your response is on behalf of the Democratic Conference, in addition to the Majority Coalition Leaders.
