DR. MOSES WEINSTEIN, duly sworn, deposes and says:

1. I am a resident of the County of Kings, City and State of New York and make this Affidavit in support of the above-captioned lawsuit and Petitioner's application for a preliminary injunction to prevent Respondent from summarily dismissing any more complaints of judicial misconduct pending the outcome of this litigation.

2. I am a clinical member of the American Association for Marriage and Family Therapy and a member of the Board of Directors of the New York Association for Marriage and Family Therapy. I am co-Director of the Family Institute of New York and Executive Vice-President of Fathers Rights Metro.

3. I hold a doctorate in psychology and hold multiple professional licenses in states throughout the country and have been qualified as an expert witness in family therapy in various court matters more than 350 times in ten states and three countries. My curriculum vitae is annexed hereto for the

Court's further information.

4. Within the past five years, I have filed over 100 complaints with Respondent involving judges in both the First and Second Judicial Departments on behalf of men and women in litigation before the courts in those Departments.

5. Every one of these complaints which were meticulously detailed and documented with evidentiary material of substance establishing, unequivocally, serious violations of judicial duty were summarily dismissed without any investigation and without any reasons for dispensing with investigation.

6. Every of these complaints was followed up by me personally, demanding reasons for such dismissals, all of which were rejected by the Commission.

7. Additionally, I sent over ten letters to Honorable Guy Mangano, Presiding Justice of the Second Judicial Department, informing him of the foregoing dismissals and requesting his assistance in obtaining appointment of an independent commission to investigate the Commission on Judicial Conduct, Gerald Stern, Administrator, and all complaints filed with his office in the last five years.

8. All of the aforesaid efforts were to no avail.

9. I totally support Petitioner's lawsuit against the Commission on Judicial Conduct, and speak for the over 3,000 members of Fathers' Rights Metro and the Family Therapy Institute of New York in so doing.

10. I intend to move promptly for intervention in this

historic case.
