Following up my phone call to you a short time ago, enclosed is a copy of Mr. Moore's December 10, 1998 letter to State Senate Judiciary Committee Chairman James Lack, advising him that the State Bar's Committee on Judicial Selection had found Justice Albert Rosenblatt "Well Qualified" to be an associate judge of the New York Court of Appeals.

The letter refers to the "Guidelines for Evaluating Qualifications of Judicial Candidates", adopted by the State Bar's House of Delegates, and indicates that a copy was enclosed.
