Following up my telephone conversation with Assistant Attorney General Vale at about 3:30 pm yesterday and the phone messages I left for all other counsel shortly thereafter -- while waiting in the *ex parte* office, after paying the \$45 fee for the OSC/TRO -- I was instructed to and did bring up the papers to Justice Schlesinger's courtroom 222. However, because it was a motion day and Justice Schlesinger was already very busy, she could not entertain the OSC/TRO. We will be advised as to when she can hear it.
