Thank you for your interest in testifying at this year's budget hearing.

As per our conversation, in order to be considered to testify at the Public Protection Budget Hearing, you are required to submit your testimony electronically by replying to this email no later than 24 hours prior to the date of the hearing. Upon receiving your testimony electronically, your organization's testimony will be kept on file and become part of the hearing record. Should the hearing schedule permit, we will contact you the day before the date of the hearing with the time at which you are scheduled. When testifying, in the interest of time, please present the key points of your testimony.

It is important to note that submitting your testimony electronically does not guarantee you will be testifying at the hearing. If you are not notified that you will be testifying, your electronically submitted testimony will become part of the hearing record. If you do not wish to testify in person, you may still submit ten copies of your testimony to this office within ten days after the scheduled hearing date and it will become part of the hearing record. No PowerPoint presentations will be accepted.

If you are selected to testify at the hearing, you are also required to also bring 50 printed copies of the testimony to the door on the day of the hearing for distribution to committee members.
