# TO: Mike Agnostikis/Investigations Aide to Chairman James Skoufis/Senate Committee on Investigations & Government Operations

Thank you for your call back, this morning. I am excited to be able to assist Chair Skoufis and the vital Senate Committee on Investigations & Government Operations he chairs in "putting the house in order" – the "house" being not just the Senate, but the Assembly – and the executive and judicial branches of our state government. All three branches have become profoundly dysfunctional and corrupted – and the most important reason is because the Legislature has failed and refused to effect oversight over itself and our two other branches. Its legislative committees have been sham and essentially pass-throughs for rubber-stamping flawed legislation that is the product of deal-making by leadership, not any cognizable legislative "process", *to wit*, hearings, investigations, fact-finding reports, legislation based thereon, amended upon discussion, deliberation, and votes in committees, and likewise on the floor of the Senate and Assembly, thereafter reconciled through conference committees.

As discussed, the below (with its above 2 attachments) reflects my contact, two years ago, with Carlos Valle – occasioned by then Assemblyman Skoufis' membership on the Assembly Committee on Local Governments, which has oversight responsibilities over district attorneys, whose salaries – tied to judicial salaries -- come out of the county budgets and as to which there has been NO oversight for more than 40 years. Here's the link to CJA's webpage posting the video of my testimony about it, three days later, at the Legislature's January 30, 2017 budget hearing on "local government officials/general government" – and highlighting the significance of CJA's 2<sup>nd</sup> citizen-taxpayer action, suing all three government branches, including with a 10<sup>th</sup> cause of action addressed to the D.A. salary/reimbursement issue: http://www.judgewatch.org/web-pages/searching-nys/2017-legislature/budgethearings.htm. Two months later, I would embody that testimony and the further testimony I gave on January 31, 2017 at the Legislature's "public protection" budget hearing in a March 29, 2017 verified supplemental complaint in the 2<sup>nd</sup> citizen-taxpayer action (at ¶¶193-215) – a copy of which I gave, in hand, on May 3, 2017, to Senator Michael Gianaris, whose remarks on the Senate floor with respect to the Senate's one-house budget resolution are also quoted therein ( $\P 246$ ). Senator Gianaris is a lawyer with a Harvard Law School degree – and "full-time legislator with no outside earned income". So, too, Senator Brad Hoylman, the then-ranking member of BOTH the Senate Committee on Investigations & Government Operations AND the Senate Judiciary Committee, is a "full-time legislator"-lawyer, with a Harvard Law School degree. Likewise, my own Assemblyman, David Buchwald, a "full-time legislator"lawyer, with a Harvard Law School degree, who then, as now, is a member of three pertinent Assembly committees: Judiciary, Local Governments, and Governmental Operations. This too is recited by the March 29, 2017 verified supplemental complaint ( $\P$  225-228) – perhaps the best starting point for you, as a lawyer, to understand the enormity of what the 2<sup>nd</sup> citizen-taxpayer action chronicles, covered up by New York's attorney general and judiciary, who, for years, have collusively corrupted the judicial process to "throw" meritorious citizen-lawsuits, suing the state and its public officers for their unlawful, unconstitutional conduct, with no oversight examination of what's been going on by the Legislature or anyone else. ### Subject: Oversight by Assembly Committee on Local Governments, beginning with the striking of the \$4,212,000 D.A. salary grants in Aid to Localities Budget Bill A.3003 (at p. 61)

### TO: Scott Esty, Chief of Staff to <u>Assemblyman Christopher Friend/Ranking Member, Assembly</u> <u>Committee on Local Governments</u>

Thank you for your return call yesterday – and the generous amount of time you gave to our conversation.

Below is the e-mail I had sent earlier in the day to your counterpart in Assemblyman Magnarelli's office – his legislative director & counsel Craig Swiecki – concerning the same issues I thereafter discussed with you: the failure of ANY legislative committee to discharge oversight responsibilities over the state's district attorneys – who, upon information and belief, are the HIGHEST PAID elected county officers by many, many tens of thousands of dollars in every county, other than the five counties of New York City

and Hamilton County – the state's least populous county and the only one whose district attorney is part-time – many, if not most of whom, enjoy combined salary and non-salary compensation of approximately \$220,000 per year. This is the direct result of:

(1) the 40 year-old statute, Judiciary Law §183-a, linking the district attorney salaries of various counties, which are paid by the counties, to judicial salaries, which are paid by the state;

(2) County Law §700.10 and §700.11, providing for state reimbursement to the counties of a portion of the increased district attorney salary costs resulting therefrom;

(3) the Governor's Aid to Localities budget bills, whose appropriations for grants for district attorney salaries not only violate County Law §700.10 and §700.11, but Judiciary Law §183-a, as well.

These issues are presented (at ¶¶4, 31-33, 65, 79-80)of the September 2, 2016 verified complaint in CJA's second citizen-taxpayer action against the Governor and Legislature, among others. Its culminating 10<sup>th</sup> cause of action (¶¶85-110) particularizes the unlawfulness and unconstitutionality of the appropriation and reappropriation of state monies for district attorney salaries in the enacted Aid to Localities budget bill for fiscal year 2016-2017 -- #S.6403-d/A.9003-d.

The September 2, 2016 verified complaint and the lawsuit record are posted on CJA's website, <u>www.judgewatch.org</u>, accessible from the prominent homepage link "CJA's Citizen-Taxpayer Actions to End NYS' Corrupt Budget 'Process' and Unconstitutional 'Three Men in a Room' Governance." As <u>eight</u> <u>of the 20 members of the Assembly Committee on Local Governments are lawyers</u>: Bronson, Buchwald, Jenne, McKevitt, Otis, Ryan, Wallace – and, of course, Chairman Magnarelli – it has ample legal expertise from which to <u>independently</u> confirm what the other <u>12 non-lawyer members</u> can <u>readily</u> discern from the lawsuit record: plaintiffs' entitlement to summary judgment on their 10<sup>th</sup> cause of action, *as a matter of law* – and, likewise, to summary judgment, *as a matter of law*, on the predecessor nine causes of action – necessitating swift legislative action, beginning with the striking of the \$4,212,000 appropriation in this year's Aid to Localities Budget Bill #S.2003/A.2003 (at p. 61) "For grants to counties for district attorney salaries" – an appropriation materially identical to that challenged by the 10<sup>th</sup> cause of action.

I have requested to testify in opposition to Aid to Localities Budget Bill #S.2003/A.3003 at the Legislature's January 30<sup>th</sup> budget hearing on "Local Government Officials/General Government" – and look forward to answering the Committee's questions at that time. However, I am available before then and would welcome the opportunity to speak directly with Ranking Member Friend, Chairman Magnarelli, or any other Committee member in advance of the budget hearing – all of whom I am furnishing this e-mail with that invitation. For the convenience of all, and for the chairs and ranking members of the Assembly Ways and Means Committee and Senate Finance Committee, to whom I am also furnishing this e-mail, the pertinent \$4,212,000 appropriation from this year's and last year's Aid to Localities budget bills are attached.
