This follows the call I received at about 11 am today from Public Corruption Unit paralegal Micki, who told me she was returning my several phone messages (212-335-8987) – apparently from June – and pertaining to my above-attached June 9, 2020 public corruption/grand jury complaint against New York County state legislators, addressed to New York County District Attorney Vance. She stated she did not have the complaint – or my above-attached July 29, 2020 FOIL request arising therefrom. I, therefore, showed her both from CJA's website, <a href="www.judgewatch.org">www.judgewatch.org</a> – accessible via the top link "Latest News": <a href="http://www.judgewatch.org/web-pages/cja/latest-news.htm">http://www.judgewatch.org/web-pages/cja/latest-news.htm</a>.

Below are the three e-mails transmitting the June 9, 2020 complaint to D.A. Vance – with the third e-mail also transmitting the July 29, 2020 FOIL request. If D.A. Vance did not forward you the complaint and FOIL request – and my e-mails to him did not bounce back – this should be concerning – and the subject of investigation.

Suffice to add that I made it a point to show Micki the substantiating evidentiary webpage for the complaint: <a href="http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm">http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm</a> — and had her open the first link in its complaint "SUMMARY": <a href="CJA's July 16, 2019 e-mail">CJA's July 16, 2019 e-mail</a> to, <a href="internation-mail">internation-mail</a> NYS Senate Finance Committee Chair Liz Krueger, the MOST IMPORTANT of New York County's 18 state legislators over whom District Attorney Vance has criminal jurisdiction. As I stated to Micki, the **prima facie**, **open-and-shut EVIDENCE** against Senator Krueger pertaining to the scheme of fraudulent, statutorily-violative, and unconstitutional commission/committee based pay raises — and the state budget — spans back more than seven years, to February 6, 2013, when I first testified before her.
