This follows up my disturbing phone conversation a short time ago, with Amber, a “special assistant” in your district office. I telephoned your district office requesting to speak with David Fischer, your Legislative Director/Chief of Staff, because I had received no response from him or anyone on his or your behalf to my below May 21<sup>st</sup> e-mail, addressed to him – with a copy to you – requesting to “discuss matters requiring urgent, PRIORITY ATTENTION by the Assembly Committee on Oversight, Analysis and Investigation, now chaired by [you], and also within the purview of the Assembly Judiciary Committee and Assembly Ways and Means Committee, of which [you are] a member.”

After putting me on hold, Amber stated that Mr. Fischer was “not available”, but that if he had “any questions” about my e-mail, he would call me. I protested that this response made no sense at all – as my e-mail had NOT specified the “urgent, PRIORITY” matters I wished to discuss. Nonetheless, she would not reassure me that Mr. Fischer would be calling me back.

Do you – or Mr. Fischer – already know who I am and why I am calling? If so, Mr. Fischer should be eager to speak with me IMMEDIATELY, in discharge of his responsibilities to you as chair of the Assembly Committee on Oversight, Analysis and Investigation, for which you are collecting a lulu. Please advise – and indicate when I can expect a call from Mr. Fischer – or from you.
