Inasmuch as yesterday's <u>Daily News</u> ran a fourth editorial in two weeks endorsing "gubernatorial appointment-legislative approval method" of judicial selection as putting "merit" over politics, please advise when the Editorial Board would like to meet with me to review the *evidentiary proof* of how politicized and corrupted such "method" *actually* is – be it to New York's "lower" state courts or to our Court of Appeals.

You will recall that in our November 28th phone conversation – following the first of these editorials – you were receptive to my suggestion that the <u>Daily News</u> examine the process by which Governor Pataki has made hundreds of judicial appointments during his seven years in office, *all* I believe confirmed by *unanimous* Senate votes. My November 30th letter to you reiterated the necessity of such examination – offering to combine a personal presentation about the corruption of the judicial appointments process with a presentation about the corruption of the State Commission on Judicial Conduct.

Finally, notwithstanding yesterday's <u>Daily News</u>' editorial extends accolades to Chief Judge Kaye and Chief Administrative Judge Lippman, I trust you and other Editorial Board members saw my letter to the editor in the December 7th <u>Daily News</u> under the title "Judicial Reforms". In the event you have not seen the original – whose express identification of Chief Judge Kaye's responsibility for the perpetuation of abuses is
