In "Enabling Eliot's Illusion: Lessons of the '06 NY governor race" (3/17/08), John Faso writes about the media's "credulousness" and failure to analyze Eliot Spitzer's campaign claims and record in the 2006 gubernatorial election.

Yet, Mr. Faso is silent about his own failure, as the 2006 Republican nominee, to expose what the media had known, but not reported: Mr. Spitzer's record of corruption as Attorney General – beginning with the hoax of his "public integrity unit" and *modus operandi* of litigation fraud to defeat citizen lawsuits challenging the very governmental corruption his "public integrity unit" was neither investigating nor prosecuting.

Exposing this would have won the election for Mr. Faso, bringing Mr. Spitzer's candidacy "to an explosive and scandalous end". We wrote this in a letter to Mr. Faso entitled "Informing the Voters: Attorney General Eliot Spitzer's *readily-verifiable* corruption in office – covered up by an election-rigging press". That was more than four months before the election.

Readers can judge Mr. Faso's complicity with the media in engineering Mr. Spitzer's landslide victory. The letter is on our website, www.judgewatch.org, with the documentary evidence substantiating it.

If the media has learned any "lesson", it will now probe Mr. Spitzer's record as Attorney General. Such will propel systemic reforms more sweeping than any Mr. Spitzer might have advanced – or Mr. Faso.
