Dear Professors, Etc. -

On December 30, 2013, the Center for Judicial Accountability (CJA) wrote a letter to Governor Cuomo, summarizing the unconstitutionality and fraudulence of the <u>Legislature's proposed budget</u> for fiscal year 2014-2015, proposing procedures for its review and rejection consistent with the Constitution, and identifying (at p. 7) that we would be furnishing the letter "to scholars of New York's budget and Constitution, bar associations with committees pertaining to these, and so-called 'good government groups' so that they may contribute their informed views to [the Governor] and the Legislature."

Subject: Expert Opinion-Scholarship Needed: NYS Budget

Dear Professors, Etc.

This follows my below November 29th e-mail, to which I received no response.

On December 11th, our non-partisan, non-profit citizens' organization wrote the Governor and Legislature, calling upon them to reject the Judiciary's proposed budget for the upcoming fiscal year as unconstitutional for lack of sufficient and meaningful itemization and violative of Article VII, § 7 of the New York State Constitution. Indeed, we also furnished the letter to the Commission to Investigate Public Corruption so that it could investigate the slush fund the proposed Judiciary budget creates – beginning with its completely unitemized, concealed appropriation of monies for the third phase of the judicial salary increase, the larcenous nature of which is established by CJA's October 27, 2011 Opposition Report to the August 29, 2011 Report of the Commission on Judicial Compensation and the four causes of action of our People's lawsuit based thereon, *CJA v. Cuomo, et al.*

Page 8 identifies that we would be "contacting scholars of New York's Constitution and budget" to request that they offer their expert opinion.

Subject: BUILDING SCHOLARSHIP: Commission to Investigate Public Corruption -- & the Upcoming Budget for Fiscal Year 2014-2015

Dear Professors, Etc.

This Sunday, December 1, 2013, is the date by which – pursuant to Section VIII of Governor Cuomo's Executive Order #106 -- the Commission to Investigate Public Corruption is required to issue a "preliminary policy report...setting forth its initial findings and making such recommendations...for the express purpose of consideration and enactment of statutory reforms by the Governor and the Legislature in the 2014 legislative session".

It is also the date by which – pursuant to Article VII, Sec. 1 of the New York State Constitution — the Judicial and Legislative branches are required to furnish their "itemized estimates" of their "financial needs" to the Governor, with a copy of the Judiciary's "itemized estimates" "transmitted to the appropriate committees of the legislature".

If your scholarship does <u>not</u> embrace these, I trust you will <u>not</u> be writing or giving comment to the press about them. If, however, they are within your scholarship, please let me hear from you *as soon as possible* about the primary-source documentary evidence of which my below October 24th e-mail gave you notice. To date, I have received no response from even a single scholar to my <u>August 21st letter to the Governor</u> or to my <u>August 5th letter to the Commission</u>, let alone to my <u>September 17th written and oral testimony to the Commission</u> or subsequent correspondence as, for instance, my October 17th letter to the Commission, posted as our webpage entitled: <u>The People Have Something to Say -- & Evidence to Back It Up.</u>

How would you explain this? Is there an explanation other than conflicts of interest?

Needless to say, New York government will never be other than flagrantly and systemically dysfunctional and corrupt unless we build honest scholarship that is <u>methodologically-sound</u> and based on primary-source documentary evidence that is <u>not</u> cherry-picked. To that end – and especially if you will not be confronting this evidence – I would appreciate the names of other scholars of New York's Constitution, governance, and politics to whom we and the press can turn.

"Wow! What a devastating presentation. Thank you Joel Rose for writing this -- and Artvoice for circulating it. I will e-mail it to reporters & editors, political and constitutional scholars & commentators -- and to the membership of our non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc. (CJA), with a request that it be forwarded on, and on, and on.

I would note that on October 8th, [Bill] Samuels, who funds an organization called "Effective New York" and another called "New Roosevelt", held a conference on a new New York Constitution, with the first segment on the six constitutional propositions on this year's ballot, including one to raise the mandatory retirement age for various NYS judges from 70 to 80. In the question portion, I asked how many of these constitutional propositions were the product of a legitimate legislative process -- that is, introduced by legislators into committee, with public hearings then held at which citizens and experts could testify, followed by debate by committee members based thereon, mark-ups, amendments, committee votes -- embodied in committee reports -- then moved to the full Senate and Assembly, with debate and amendments before votes -- with the final legislation of each house then reconciled by conference committees. Only by such process are we protected against flawed legislation. The answer from the panelists was -- or so it seemed -- that none of the constitutional propositions on the ballot had resulted from such process.

We, the People, must take action to protect the desecration of legitimate, constitutional governance by our public officers -- and by their protectors in the media, academia, and elsewhere.

MORE TO FOLLOW -

Essential scholarship, based on primary-source documentary evidence, is completely lacking as to the Commission to Investigate Public Corruption, as to which reporting has been utterly and knowingly superficial and skewed.
