Dear Mr. Barnes:

This confirms our October 2^{nd} telephone conversation, wherein I requested – and I believe you agreed -- that the ACLU's Legal Committee would reconsider my July 7th letter for legal assistance in the above-entitled case at its next meeting, scheduled for Thursday, October 16th.

Such is appropriate as it appears that my July 7th letter – setting forth the very basis upon which I was seeking the ACLU's assistance – was NOT shown to Committee members at the prior September 24^{th} meeting at which they declined to assist me. Nor does it appear that Committee members were even made aware of what my July 7th letter specifically highlighted as "The important proposition to be championed in this case – worthy of the ACLU's advocacy" --

"that 'a citizen's respectful request to testify at a congressional committee's public hearing is not – and must never be deemed to be – 'disruption of Congress'"." (emphasis in the original).

This is evident from Friz Mulhauser's September 25th rejection letter – and reinforced by my September 29th telephone conversation with Arthur Spitzer and, thereafter, with you.

If, after Committee members have each reviewed my July 7^{th} letter – and its accompanying June 16^{th} memorandum to Ralph Nader, Public Citizen, and Common Cause – to which the ACLU is an indicated recipient – they deny or dispute that this is the important proposition of fundamental citizen rights for which "new law needs to be made and can be" -- where, additionally, they have the videotape of "the event" and a bonanza of "pure gold" substantiating documents – I respectfully request that they so-state in a rejection letter signed by you as Executive Director.

Trusting that you and Mr. Spitzer will effectuate this reasonable reconsideration request – and that the Legal Committee will recognize how utterly incongruous it would be for the ACLU of the National Capital Area not to seize the opportunity to vindicate "a citizen's respectful request to testify at a congressional committee's public hearing" – as to which this is the MOST PERFECT of cases -- I have obtained an adjournment of the court conference for ascertainment of counsel to October 16th, at 2:00 p.m.

Needless to say, while in Washington on October 16th it would be easy for me to meet with Committee members to answer their questions about the case – and its potential to achieve sweeping good government reform. Please let me know if this would be helpful.
