05/20/2003 Uz Kalley, Office Manager for Senator Clinton's Washington, DC office (Turner regarding a telephone call and fax received from SASSOWER. Due to scheduling conflicts, SA Lippay was

SA Lippay made a copy of the voice mail message, in which SASSOWER directs her message to a staff member and spoke in a calm, coherent tone. SASSOWER stated that members of the Senator's staff engaged in "misconduct" regarding a judicial nomination [nature of the misconduct was not provided]. SASSOWER would like to discuss the misconduct with the staff member and provided her call-back number.

SASSOWER also sent a fax to the office, which Ms. Kelley faxed to the TAS. In the correspondence, SASSOWER requested the opportunity for Center for Judicial Accountability, of which she serves as Coordinator, "to testify in opposition at the May 22, 2003 hearing on Judge Wesley's confirmation" and "Withdrawal of your 'blue slips' approving Senate confirmation of Judge Wesley and of P. Kevin Castel, Esq."

No threats or harassing language were contained in either the voice mail message nor the fax.

SA Lippay left a voice mall message for Ms. Kelley at approximately 1945 hours, shortly after being assigned the case, in order to determine the office's concern regarding SASSOWER's behavior.

SASSOWER has a prior record with the TAS that involves two cases that occurred in 1992 and in 1996. Details regarding the 1992 case are not available. In 1996, it appears as though SASSOWER was arrested in the DSOB for 521

Ms. Kelley telephoned SA Lippay regarding SASSOWER. According to Ms. Kelley, the subject "stalked" and "harassed" associates of the Senator's legal counsel. Ms. Kelley raterred SA Lippay to Aleecia Evel was the subject of the stalking and harassment,

SA Lippay telephoned Ms. Eve, who stated that SASSOWER presents herself in a professional manner but does not act in a rational manner. SASSOWER has sent approximately six boxes of documents to the Judiciary Committee regarding her interest in the nomination of Judge Wesley.

Ms. Eve advised that SASSOWER is not an attorney, although she attempts to give such an impression.

SASSOWER's mother is believed to be deceased. The mother is currently listed as Director of the Center for Judicial Accountability, an organization which, Ms. Eve stated, consists of only one individual: SASSOWER. In the 1990's, the mother's NY bar license was revoked. The mother filed an appeal, and Judge Wesley, who is currently a judge in NY, sat on the court that heard the appeal. The court ruled to NOT reverse the decision to revoke the license. Since that time, SASSOWER has filed suits against the judges involved in the decision, claiming the judges

As SASSOWER has made calls and sent faxes to the Senator's office regarding the judge's nomination, Ms. Eve and Josh Albert, another colleague, met with her this week for 40 minutes, during which time they allowed her to vent. At the end of the meeting, SASSOWER asked if the Senator was going to withdraw her vote for the Judge, which the staff answered "no." SASSOWER then asked if she could meet with the Senator, and again was informed "no." At that point, the subject began yelling at the staff.

Ms. Eve believes that SASSOWER may travel to DC in an attempt to verbally disrupt tomorrow's hearing.

. SA Lippay telephoned NY DMV for SASSOWER's photo, NY requires a subposina for generation of a photo.

Detective Zimmerman located SASSOWER's USCP arrest photo from 1996,

SA Lippay created a bulletin for Ms. Kelley's office, containing the color photo and physical identifiers, and a version

SA Lippay delivered the bulletins to Sergeant Nicholas, Senate Division, and telephonically notified SA Orquiza, DPD, who is on the Senator's protective detail. A bulletin was faxed to DPD and SA Orquiza will respond to the TAS for the

Ms. Kelley later notified the TAS that SASSOWER left a voice mail message on the office's system this morning. SA Lippay made an audio copy of the massage, in which the subject requested a call back from the Senator's COS regarding the subject's call with Ms. Eve and Mr. Albert. SA Lippay advised Ms. Kelley that this investigator would

SA Lippay then called the subject, who was initially cooperative until this investigator informed her as to the nature of the call. SASSOWER then began to speak in a loud tone; SA Lippay experienced difficulty interrupting the subject. When asked by SA Lippay, SASSOWER advised that she plane to attend the hearing tomorrow but would not state whether or not she plans to disrupt the meeting. SASSOWER denied being arrested in 1996, although this investigator has on file the subject's USCP arrest photo. When SASSOWER asked to speak with SA Lippay's supervisor, this investigator placed Detective Zimmerman on the line.

SA Lippay notified Sergeant Sundberg, who acts as liaison with Senate Committees, regarding SASSOWER's planned attendence at the hearing. The Sergeant will notify the Judicial Committee concerning the situation.

SA Lippay will respond to the hearing prior to its 1400 hours start.
