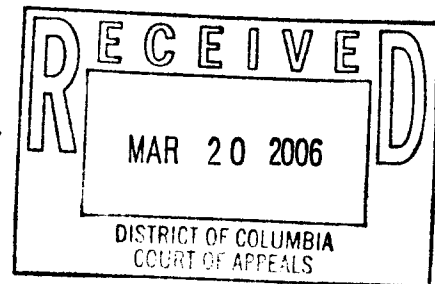

ELENA RUTH SASSOWER, being duly sworn, deposes and says:

1. I am the appellant *pro se* in the above-numbered consolidated appeals and submit this motion for permission to file¹ my accompanying unopposed motion for a procedural order for an extension of time for the filing of my reply brief, currently due on April 5, 2006.

Such is without prejudice to my contention, already particularized², that this Court is disqualified for pervasive actual bias and interest and that these appeals must be transferred to the U.S. Court of Appeals for the District of Columbia.

2. The instant motion is necessitated by the *unsigned* October 27, 2005 order of Judges Reid, Glickman, and Nebeker (Exhibit A), which, *sua sponte and without any due process*, directed this Court's Clerk "to accept no further filings from [me] except [my] conforming brief on the merits, due on November 7, 2005, and a conforming reply brief, if any, due within 21 days after the filing of appellee's brief on the merits".

3. The pertinent facts pertaining to such unprecedented and severely prejudicial October 27, 2005 order have been particularized by me in a January 10, 2006 letter to Chief Judge Eric Washington (Exhibit B), to which I received no response, and in a February 22, 2006 judicial misconduct complaint (Exhibit C), presently pending before the D.C. Commission on Judicial Disabilities and Tenure. In the interest of economy, I incorporate them herein by reference.

WHEREFORE, I respectfully request permission to file my accompanying unopposed motion for a procedural order for an extension of time for the filing of my reply brief.
