How disappointing to have received no response from you to my below May 22nd e-mail. As stated, "You can win your Democratic primary for New York's 92nd Assembly seat, easily and without money – and the general election – against Assemblyman Abinanti, a lawyer. All it takes is 'whistle-blowing' from the bully-pulpit of your candidacy."

To prove it – and further assist you – attached is the corruption/grand jury complaint against Assemblyman Abinanti that I filed with Westchester District Attorney Scarpino on June 10th. ALL the substantiating EVIDENCE to which it refers is posted on CJA's webpage for the complaint, here: <http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm>. It should not take you long to recognize that Assemblyman Abinanti cannot be re-elected, because he must be indicted and will be convicted. Again, I invite you to call me. If you are a serious candidate, no further time should be wasted. You must use the "bully-pulpit" of your candidacy – and forward the June 10th corruption/grand jury complaint to the press, demand Assemblyman Abinanti's response, & call upon Westchester D.A. Scarpino to expedite his time-table for investigation & grand jury inquiry & indictments. It takes no money for you to do this – and a relatively minimal expenditure of time.
