This is to alert you to GOOD NEWS. You can EASILY win election to the state legislative seats you seek – and without expenditure of money. As you know, Erie County's 13 state legislators – 9 running for re-election and 2 running for higher offices – are the subjects of a **fully-documented** public corruption/grand jury complaint, filed with Erie County District Attorney Flynn, himself running for re-election, who has been "sitting on" it. The complaint involves the "force of law" commission/committee scheme that gave <u>all 14 of them</u> pay raises – and a legislature <u>not</u> operating at a remotely constitutional level.

The June 12, 2020 complaint, by the Center for Judicial Accountability, Inc. (CJA), is above-attached – and below are the e-mails transmitting it and the above-attached July 27, 2020 FOIL request to D.A. Flynn. CJA's substantiating evidentiary webpage for the complaint is here: <a href="http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm">http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm</a>.

As stated by the complaint, Erie County voters are entitled to know that their state legislators cannot be re-elected or elected to higher offices because they must be indicted for larceny and other corruption on EVIDENCE so DISPOSITIVE as

to assure convictions. So, too, retiring Senator Ranzenhofer and Assemblyman Schimminger, who will be pocketing salary-based pensions which are also larcenous.

To facilitate your inquiries of the complained-against state legislators and D.A. Flynn, I am cc'ing them on this email. What, if anything, do they deny or dispute. Let them start where the complaint starts: my July 16, 2019 e-mail to Assembly Majority Leader Peoples-Stokes and the Legislature's 14 other stipend-receiving leaders requesting that they forward the e-mail to the 198 other state legislators, with its attached July 15, 2019 written NOTICE and substantiating analysis establishing that the December 10, 2018 Report of the Committee on Legislative and Executive Compensation raising their legislative salaries from \$79,500 to \$110,000 – is "'a fraud on the People of the State of New York – and a larceny of their tax dollars', violating a succession of penal laws, and that their duty was to void it, to return the payraise monies they had already received, and to initiate criminal prosecutions of the Committee's four members and abetting attorneys." The analysis is 46 pages, excluding exhibits. Will they furnish you with their findings of fact and conclusions of law? If not, I'm sure ordinary Erie County citizens would be able to help you with what is obvious. Just accompany your story with links to the complaint and the evidentiary webpage so that they can see for themselves the open-and-shut, prima facie EVIDENCE that D.A. Flynn has been withholding from an Erie County grand jury to maintain his own fraudulently-boosted D.A. salary, paid by Erie County taxpayers.

I am available to answer your questions and assist you, to the max — on a story not only upending Erie County's state legislative and D.A. races, but, additionally, ALL New York's other state legislative races and its 14 other D.A. races — and that's for starters.

## **TO: Erie County District Attorney John Flynn**

I have received no acknowledgment or other response from you to my above-attached public corruption/grand jury complaint against Erie County state legislators, which I sent you at 11:49 am on Friday, June 12, 2020 by the below e-mail, with a direct link to the substantiating evidentiary webpage: <a href="http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm">http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/grand-juries.htm</a>. A short time earlier, I had submitted it to your Public Integrity Unit, *via* its website portal: <a href="https://www2.erie.gov/da/index.php?q=public-integrity-complaint-form">https://www2.erie.gov/da/index.php?q=public-integrity-complaint-form</a>. As the portal has NO attachment feature, I stated: "The complaint of today's date, addressed to Erie County District Attorney Flynn, is posted on the website of the non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc. (CJA), here: <a href="http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/da-complaints-to-soares-plus-61-more.htm">http://www.judgewatch.org/web-pages/searching-nys/2020-legislative/da-complaints-to-soares-plus-61-more.htm</a>.

Seemingly, it was in response to that portal transmittal – or to the phone message I had left about the complaint, also on Friday morning June 12<sup>th</sup> (716-858-2424) – that I received a phone call on Monday, June 15<sup>th</sup>, at about 9:30 a.m., from a female staffer who tried to brush me off, without having read the complaint or examining its substantiating proof. My

reply was to guide her to CJA's website, <a href="www.judgewatch.org">www.judgewatch.org</a>, and the relevant webpages. After eye-balling the posted complaint and the evidence substantiating it, the staffer quickly disconnected the call, as I was asking her name.

It takes no more than "eye-balling" the complaint and its substantiating evidence to know that a grand jury would speedily indict — and a trial jury speedily convict — the complained-against Erie County state legislators and their accomplices. Consequently, your nonfeasance raises reasonable questions as to your performance with respect to other public corruption complaints filed by other members of the public. So, too, the non-feasance of your "Public Integrity Unit". To help answer these questions, I have today filed a FOIL/information request with Erie County FOIL Officer & Second Assistant County Attorney Jeremy Toth — to which you are cc'd. It is attached.
