This is to alert you to the GOOD NEWS – which New York's "fake news"/election-rigging, corruption-abetting journalism has been concealing. You can win election easily and without money against Manhattan's re-election-seeking legislative incumbents. All it requires is using the "bully-pulpit" of your candidacy to whistle-blow about the above-attached FULLY-DOCUMENTED public corruption/grand jury complaint against them, which Manhattan District Attorney Cyrus Vance has been "sitting on".
