As the press will be interviewing you, in the coming weeks, about your candidacies – including for purposes of editorial endorsements – it is essential that you know what the press already knows – namely, that Suffolk County's 14 incumbent state legislators running for re-election or higher office must be indicted for fraud, larceny, and other corruption on EVIDENCE so *prima-facie* and open-and-shut as to assure their convictions. The particulars are set forth in the above two materially-identical public corruption/grand jury complaints, filed with Suffolk County District Attorney Sini and Nassau County District Attorney Singas, who are "sitting on" them. This is discussed by my below September 27<sup>th</sup> e-mail to Long Island's key newspaper/news website chains – cc'ing [LIHERALD.com](http://LIHERALD.com) and [Newsday](http://Newsday), both of which will be endorsing candidates.

Individually and collectively, if you stand up for honest, accountable government and make the complaints your campaign issue, you will win – easily. Demand that the complained-against legislators respond to the

complaints, that the district attorneys explain why they have not presented them to grand juries, and that the press do its part to investigate and report.

I am available to answer your questions – and invite you to call. Needless to say, voters are entitled to know what salary you expect to be paid, if they elect you to the Legislature – and your pledge to ensure: (1) public findings of fact and conclusions of law with respect to the complaints; (2) prosecution of all culpable public officers and their conspirators; and (3) “claw-backs” to recover the approximately half-a-billion dollars in fraudulent salary increases, already paid out.

Finally, I ask your help in forwarding this e-mail to the above-listed candidates whose names are preceded by an asterisk (\*), as I was unable to find e-mail addresses for them, including because they apparently have neither campaign websites or facebook pages.
