I have received no responses from you, individually or collectively, to my below August 15th e-mail, also sent [a second time](#) – and no response from UJA-NY, as well.

How is this possible in a matter of such profound consequence to the Jewish People, Israel, and to lawful, constitutional NYS governance?

As you are nine rabbis, please give me the common courtesy of an explanation, so that I may understand how your actions and inactions – resulting in NO response from UJA-NY – are consistent with the most basic Jewish values, civic values, and your leadership responsibilities – and so that I may know what I must do, going forward.

Based on my knowledge of Torah and Jewish texts, codes of ethics and civic responsibility, the foundational documents and laws of our United States and New York State, and not-so-distant history, I believe my duties as a Jew and citizen are very clear – including taking action in the absence of leadership. Consequently, I have been very busy and am now endeavoring to mobilize New York's Jewish, pro-Israel, and other communities through an announcement to "[SPREAD THE WORD – Mamdani's Win as NYC Mayor is being Rigged by the NYT & Other NY Press, Concealing his Corruption as a NYS Assemblyman – A Scandal He Cannot Survive](#)".

Will you disseminate this one-page announcement to your congregants, so that they will know what the press, including UJA-supported Jewish press, are concealing from them – the truth of which you’ve had ample time to verify.

How about to the “over 750 rabbis” of the New York Board of Rabbis, whose president, unbeknownst to me until I was writing this e-mail, is Rabbi Hirsch, and whose officers include Rabbi Cosgrove, a vice president, and Rabbi Exler, a treasurer, and whose Board of Governors includes Rabbi Morgenstern and Rabbi Carter. Shouldn’t the “over 750 rabbis” be alerted to what has been going on, unreported by the press, so that they can assess their own responsibilities to their own congregants and as citizens. To that end, wouldn’t it be appropriate for the leadership of the NY Board of Rabbis to convene meetings amongst themselves and with the members for Torah-based discussion, easy to do by zoom, on the subject of their responsibilities as rabbis and citizens – and of the duty of the Board, as a collective.

By separate e-mail, I am making that request to President Hirsch and the other executive officers of the NY Board of Rabbis, for forwarding to the Board of Governors and the “over 750 rabbis”. I will be sending it shortly and thereafter will forward it to you.

It goes without saying that both that e-mail and this are occasioned by Shabbat Shoftim – and it cannot be emphasized strongly enough that Mamdani has been knowledgeable of, and complicit in, the corruption of NY’s judiciary, at its highest levels, in colluding with the legislative and executive branches in destroying constitutional, lawful state governance, of which he has been a direct beneficiary, including by his salary.

I am available to answer questions, *no matter how early or late*. Please let me hear from you by next Shabbat, as TIME IS OF THE ESSENCE.

If so, it reinforces the situation to which my yesterday’s e-mail for Board Chair Rowan and the Board members sought to alert them.

This follows your return call to me yesterday afternoon, for which I thank you.

As discussed, it is essential that [UJA Federation of New York Board Chair Marc Rowan](#) and [Board Members](#) – who, doubtless, in their individual capacities, are generously contributing to PACs opposing Mamdani's election as NYC mayor – be apprised that Mamdani's June 24th Democratic primary win was rigged by NY's press, which had the EVIDENCE of his corruption as a NYS assemblyman, but reported NOTHING – and that it has continued to rig the NYC mayoral race and polls ever since, knowing that this will reasonably enable a Mamdani victory in November. This, where it has the open-and-shut, *prima facie* EVIDENCE of Mamdani's corrupting of lawful, constitutional state governance involving the NYS budget, his legislative salary, and NY's oversight/"public protection" entities, causing vast, irreparable injury to the People of New York – mandating his indictment and ensuring his conviction.

Above-attached is the starting point of that EVIDENCE, my March 14th e-mail to Mamdani entitled "ELECTIONS ARE A TIME OF ACCOUNTABILITY...", to which he did not respond. It, along with my subsequent e-mails to Mamdani, also unresponded-to, and to NY's press based thereon, are posted on the website of the non-partisan, non-profit citizens' organization Center for Judicial Accountability, Inc. (CJA), www.judgewatch.org, of which I am co-founder and director, accessible from the prominent center link "[ELECTIONS 2025 – INFORMING THE VOTERS – ALERT: Corrupt candidates & incumbents are on the ballot](#)".

Inexplicably, Jewish and Israel-supporting press to which I have turned have also reported NOTHING. This is reflected by my below August 8th e-mail to, among others, Jeffrey Leb, identified by the [Jewish Insider's](#) July 29th article "[New York Jewish leaders reluctant to fight against Mamdani](#)" as a "political consultant who is leading a [new super PAC](#) called 'New Yorkers for a Better Future Mayor 2025' that plans to raise at least \$20 million to hit Mamdani" and who "held Zoom calls with more than 500 people and secured commitments..." (hyperlinking in the original).

You confirmed to me that Mr. Leb had been UJA-NY's director of government and external relations, but not since 2012. Surely, however, the "500 people" from whom Mr. Leb "secured commitments" include UJA-NY Board members. They need to know that no PAC is needed to raise and spend millions of dollars in the hope of defeating Mamdani. What is needed is **the certainty of Mamdani's defeat, easily-accomplished, without money, by an honest press simply doing its job of reporting on the EVIDENCE of his corruption and larceny as a NYS assemblyman.** Does UJA-NY not know of any such honest press or freelance reporters who would rise to the occasion to champion our New York State Constitution, the rule of law, Jewish values, the Jewish community, and our beloved Israel, by pumping out such honest journalism on the internet and social media?

As I believe it would be helpful if the eight rabbis serving on the UJA-NY Board furnished religious guidance as to UJA-NY's obligations in this matter – and their own – I am cc'ing them on this e-mail with a request for same.

To them, to you, to Chair Rowan and other Board members, and to UJA-NY's executive officers, I am available, *no matter how early or late*, to answer questions. TIME IS OF THE ESSENCE, obviously.

Subject: AGAIN -- The Times' "News Value" Standard & Confirmation "Through Direct Sources" -- MAMDANI, etc.

TO: New York Times Assistant Managing Editor Patrick Healy/Standards & Trust

Eight hours after sending you my below July 11th e-mail – whose several typos in Mamdani's name I have now corrected – the New York Post published "[Zohran Mamdani's campaign persona called into question by vote to give himself raise: critics](#)", identifying that "Mamdani did not respond to The Post's request for comment."

Apparently, The Post saw "news value" in its July 11th story. Do you? Will The Times be following up by requesting Mamdani's comment to The Post article – the tiniest sliver of Mamdani's hypocrisy and corruption that my below linked March 14th, March 17th, March 18th, and March 20th e-mails to him establish. Have you not yet determined their "news value"?

By the way, is The Times' May 28th article "[Mamdani Has a Thin Legislative Record but Is a Forceful Voice in Albany](#)" the only article The Times published about his record as an assemblyman – so puny that it had to be bolstered by comments from other legislators, ALL Democrats, as to his "forceful voice" "to move the ideological center of the Assembly to the left", interspliced with The Times' usual anti-Israel slanting and slander, consistent with Mamdani's lies as, for instance, in stating: "Mr. Mamdani stands firm in his defense of Palestinians in Gaza, where over [53,000 people have been killed](#) by Israeli forces" – when revealed by the hyperlink is that this figure is "according to Palestinian health officials, who do not distinguish between civilians and combatants" – in other words, it is according to Hamas.

Suffice to say, this May 28th article, by two of your three Albany reporters – recipients of my March 18th and March 20th e-mails and of my May 18th letter to Publisher Sulzberger – concealed the ENTIRETY of what the e-mails particularized, with evidence, and falsely made it appear as if there is nothing irregular

in how the Legislature operates, including pertaining to the budget and this fiscal year, and the inclusion of policy – indeed, concluding, as follows:

“Perhaps the most telling evidence of Mr. Mamdani’s evolution came earlier this month, when the budget bills came up for a vote. As in years past, they contained scores of policy changes, not all to Mr. Mamdani’s liking. Mr. Mamdani voted yes.”

For that “yes” vote alone, Mamdani cannot be elected NYC’s next mayor, because – based on my e-mails to him – he must be indicted and will be convicted of corruption. If you have any doubt of this, you should “confirm it through direct sources”, such as [former Assistant U.S. Attorney for the Eastern District of New York Jim Walden](#), running for NYC mayor as an independent, with an [anti-corruption policy platform featured on his campaign website](#).

Tellingly, [Mamdani’s campaign website contains no anti-corruption platform](#) – and none is reflected in *The Times’* July 9th guest essay “*If Zohran Mamdani Wins, Then What?*” by Ross Barkan, with its required disclosure: “In 2018, when I ran for state senator in New York City, Mr. Mamdani was my campaign manager”. Barkan, a left-wing, agenda-driven journalist, is an accomplice to the corruption of lawful, constitutional state governance involving the Legislature, the budget, and pay raises. [As far back as May 2013](#), I furnished him with the evidence of what was going on, including my [April 15, 2013 complaint to then U.S. Attorney for the Southern District of New York Preet Bharara](#) – sending him e-mail, after e-mail, to which he never responded. This includes when he was campaigning for the Senate, such as my [October 4, 2017](#) and [January 17, 2018](#) e-mails to him reflecting my entreaties that he could easily win election and, simultaneously, propel non-partisan, good-government reform if he would “blow the whistle” on the corruption of the Senate incumbent – entreaties I would repeat in my e-mails in 2020 to Mamdani, running against an Assembly incumbent. In any event, nothing could be more obscene than Barkan’s sentence, in his essay, “There cannot be any whiff of self-dealing or graft in the Mamdani administration”, considering that “self-dealing” and “graft” are precisely how Mamdani became and conducted himself as an assemblyman, in collusion with his fellow self-dealing, grafting legislators, who would then endorse and support his mayoral candidacy.

Please advise by no later than noon tomorrow, July 14th, whether you will be confirming from Mamdani the obvious truth of my e-mails to him, etc.
