I am director and co-founder of the non-partisan, non-profit citizens' organization [Center for Judicial Accountability, Inc. \(CJA\)](#).

I did not hear back from you.

Now, you are the Republican Party’s candidate for NYS comptroller – and I am writing to tell you that the SAME EVIDENCE that would have won you election, last year, as NYC mayor, will enable your win, this year, against Comptroller DiNapoli. Indeed, **the EVIDENCE not only represents an epic scandal that DiNapoli cannot survive, but brings down, as well, Governor Hochul, Attorney General James, Temporary Senate President Stewart-Cousins, Assembly Speaker Heastie, and other re-election-seeking legislative incumbents and D.A.s.**

I have already alerted Republican Party Attorney General Candidate Saritha Komatireddy and Republican election attorney/political strategist/commentator Joseph Burns to the situation – and below are my e-mails to them.

Yesterday, I endeavored to alert Republican Party Gubernatorial Candidate Bruce Blakeman. As I was unable to find an e-mail address on his campaign website or facebook, I messaged him, *via* facebook, at 6:53 p.m., stating:

"Gubernatorial Candidate Blakeman -- You can win, easily & without \$ -- & for ALL the People of the State of NY -- simply by using the bully-pulpit of your candidacy to whistle-blow about Governor Hochul's corruption, in office, destroying constitutional, lawful governance, involving the state budget, pay raises (including her own), and NY's oversight/'public protection' entities -- the subject of fully-documented criminal and ethics complaints & lawsuits vs her, AG James, Comptroller DiNapoli, Temporary Senate President Stewart-Cousins & Assembly Speaker Heastie. I assume you have Gubernatorial Candidate Blakeman's e-mail address. Kindly forward this e-mail to him and to his lieutenant governor pick, Todd Hood. I ask the same of AG Candidate Komatireddy, who, with Mr. Burns, I am cc'ing.
