Relator, GEORGE SASSOWER, Esq., as and for his
petition herein, respectfully sets forth and alleges:

AS AND FOR A FIRST CAUSE OF PETITION

1. The respondent, Hon. ROBERT ABRAMS, the Attorney
General of the State of New York, is a public agency, within the
meaning of Article 6 of the Public Officers Law.

2. That on or about the 30th day of August, 1988,
relator caused to be served upon Hon. ROBERT ABRAMS, the annexed
demand (Exhibit "A").

3. That within the five (5) business day period
provided by law, Senior Attorney DAVID S. COOK, Esq., orally
promised relator that he would respond in writing to such demand.

4. That despite such promise, no response was ever

received.

5. Thereafter, within the period provided by law, relator caused to be served upon the respondent, Hon. ROBERT ABRAMS, an appeal by reason of such non-response in writing as required by law.

6. That more than ten (10) business days has expired since the filing of such appeal, and the demand (Exhibit "A") has neither been granted nor denied.

7. That substantially similar demands were made by representatives of the media, and on information and belief, no response has been received by them, although the time for making such response has expired.

AS AND FOR A SECOND CAUSE OF PETITION

8. The respondent, OFFICE OF COURT ADMINISTRATION, is an agency within the meaning of Article 6 of the Public Officers Law of the State of New York.

9. On or about the 2nd day of September, 1988, relator caused to be served upon this respondent a demand for information (Exhibit "B" [with exhibit annexed]).

10. By letter, dated September 9, 1988, such demand was denied.

11. A timely appeal was filed with Hon. ALBERT M. ROSENBLATT, the Chief Administrator of the Office of Court Administration.

12a. More than ten (10) business days has expired since the filing of such appeal, and no response has been received with

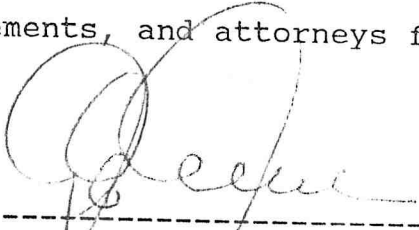
respect to same.

b. On information and belief, the respondent has also not filed any response to such appeal with the Committee on Open Government, as required by law.

WHEREFORE, it is respectfully prayed that the respondents be compelled and mandated to respond to the aforementioned demands, together with such other, further, and/or different relief as to this Court may seem just and proper in the premises, including costs, disbursements, and attorneys fees.

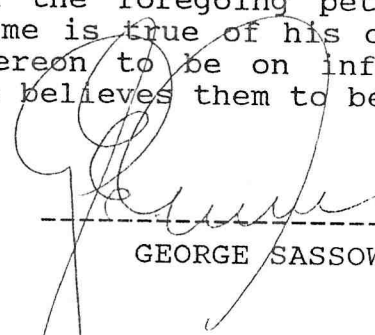

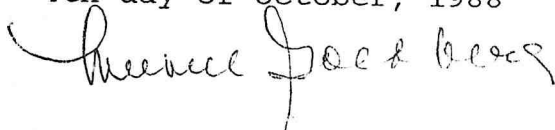
