MOURNING the death of Wangari Maathai, distinguished citizen and devoted member of her community

WHEREAS, Wangari Maathai of Kenya died on September 25, 2011, at the age of 71; and

WHEREAS, Born on April 1, 1940, in Nyeri, Kenya, in the foothills of Mount Kenya, Wangari Maathai was a star student, winning a scholarship to study biology at Mount St. Scholastica College in Atchison, Kansas, receiving a degree in 1964; she subsequently earned a Master of Science degree from the University of Pittsburgh; and

WHEREAS, Wangari Maathai went on to obtain a doctorate in veterinary anatomy at the University of Nairobi, becoming the first woman in East or Central Africa to hold such a degree; and

WHEREAS, This remarkable woman distinguished herself in her profession and by her sincere dedication and substantial contribution to the welfare of her community; and

WHEREAS, Wangari Maathai's commitment to excellence, and her spirit of humanity, carried over into all fields of enterprise, including charitable and civic endeavors; and

WHEREAS, One of the most widely respected women on the continent, Wangari Maathai played many roles - environmentalist, feminist, politician, professor, human rights advocate and head of the Green Belt Movement, which she founded in 1977 with the mission to plant trees across Kenya, fight erosion, create firewood for fuel, and create jobs for women; and

WHEREAS, Wangari Maathai won the Peace Prize in 2004 for what the Nobel committee called "her contribution to sustainable development, democracy and peace"; it was a moment of immense pride in Kenya and across Africa; and

WHEREAS, Her Green Belt Movement has planted more than 30 million trees in Africa and has helped nearly 900,000 women, according to the United Nations, while inspiring similar efforts in other African countries; and

WHEREAS, Wangari Maathai toured the world, speaking out against environmental degradation and poverty, which she said were intimately connected; and

COMMEMORATING the 200th Anniversary of the Town of New Haven, New York

WHEREAS, It is the intent of this Legislative Body to honor and commemorate the distinguished histories of the communities which comprise the noble body of this great Empire State; and

WHEREAS, Attendant to such concern, and in full accord with its long-standing traditions, this Legislative Body is justly proud to commemorate the 200th Anniversary of the Town of New Haven, Oswego County, New York; and

WHEREAS, This most auspicious occasion will commence with a celebration in the town on April 6, 2013, which will include an opening ceremony and a dedication of recent renovations to the town municipal building; and

WHEREAS, During the 2013 calendar year, the Town of New Haven will continue its bicentennial celebration using the theme "Celebrating 200 Years of New Haven Life and Patriotism", with the sale of machine embroidered lace ornaments and cookbooks containing local recipes; in addition a pictorial history of the Town containing photos of early residents, farm equipment, homes and scenery has been assembled; a Memorial Day parade will also be held, which will include floats and marchers in period costume; and

WHEREAS, New Haven was formed by law on April 2, 1813, and was the last town taken from the Town of Mexico before the organization of the present County of Oswego; and

WHEREAS, Early settlers in what is now the Town of New Haven who arrived around 1800 found dense wilderness and heavy timbers of hardwoods, and began felling the forests for agriculture, especially dairying and fruit growing; and

WHEREAS, The first road in the present town was opened before 1806, and by 1814, there were 12 road districts, with the railroad coming to the Town of New Haven in 1865; and

WHEREAS, The first Town of New Haven meeting was held at the home of Ansel Snow on April 14, 1814; David Easton was the first Town Supervisor, and Jonathan Wing was the first Town Clerk; and

WHEREAS, The first permanent settler of New Haven was Solomon Smith; he located at lot 47 in 1800, building the first log house; and

WHEREAS, In 1820, the population of the Town of New Haven was 899; by the year 2000, its population tripled with 2,930 people residing in the New Haven community; and
