Following up your return call to me, this is to reiterate that the NRA's interest in defeating Caitlin Halligan's confirmation, as expressed by its March 9th letter to Senate Judiciary Committee Chairman Leahy and Ranking Member Grassley, as well as GOA's interest, as expressed by its March 9th letter, were NOT well-served by Ranking Member Grassley's lengthy statement opposing confirmation at the Senate Judiciary Committee's March 10th Executive Business Meeting, after which he delivered a solid 8-member Republican minority vote against Ms. Halligan.

Rather, NRA and GOA have been betrayed. As discussed, what actually happened at the Committee's March 10th Executive Business Meeting is that Ranking Member Grassley and the Republican minority colluded with Chairman Leahy and the Democratic majority to conceal CJA's own March 9th letter of citizen opposition — with knowledge of its dispositive nature — enabling Chairman Leahy and the Democrats to shamelessly approve Ms. Halligan for confirmation by their 10 majority votes.

This deceit – in which Republican Senate Minority Leader McConnell and Democratic Senate Majority Leader Reid have been subsequently complicit – is set forth by CJA's March 14th letters to them entitled "Citizen Demand for Withdrawal from Today's Senate Executive Calendar &/or Senate Hold on the Confirmation of Caitlin Halligan...". The letters are attached and are also posted on CJA's website, www.judgewatch.org, on a webpage devoted to CJA's opposition to her confirmation: http://www.judgewatch.org/web-pages/judicial-selection-fed-2011.htm

To date – three days after sending these March 14th letters – neither Senate Minority Leader McConnell nor Senate Majority Leader Reid have responded; Ms. Caitlin's nomination has continued, each day, on the Senate Executive Calendar, and there is no indication of any "holds" preventing it from proceeding to a vote.

NRA and GOA would be performing a great public service if they would use their sizeable power to expose the scam that the Senators have perpetrated on them – and the American People.
