Subject: NYS Attorney General Letitia James, the NYC Mayoral Race -- & the Federal Lawsuit, CJA, et al. v. LCA, et al. (25-CV-8370)

The below e-mail makes slight, essentially non-substantive changes to the e-mail I sent you at 4:33 pm – which, with the changes, now reads:

Yesterday, by the above-attached [October 16th letter to US Attorney for the Eastern District of Virginia Lindsey Halligan](#), sent by the below two e-mails, I furnished her with the EVIDENCE of AG Letitia James' corruption, *in office*, since she was sworn into office on January 1, 2019, and how NY's press have concealed it, *in toto* – allowing AG James to publicly posture, in countering the Virginia grand jury's October 9th indictment of her for mortgage fraud, that she “will continue to fiercely protect New Yorkers and their rights” – with her co-conspirators in corruption, such as Governor Hochul and NYS Assemblyman Mamdani, doing the same, with Mamdani turning it into a rallying issue for his NYC mayoral win, which, by your journalism, you have been rigging. The EVIDENCE included the [October 8th verified complaint](#) in *CJA, et al. v. LCA, et al. (25-CV-8370)*, to which you are the first defendant.

The October 16th letter expressly requests that US Attorney Halligan:

- (1) refer the EVIDENCE of AG James' corruption *in office*, as NYS attorney general, to the Justice Department's Public Integrity Section of its Criminal Division or to its four NY US Attorneys for presentment to grand juries; and
- (2) refer the EVIDENCE of cover-up, corruption-abetting, election-rigging, journalistic fraud by the *LCA, et al.* defendants to the Justice Department and Federal Communications Commission for investigation of their “frauds and conspiracy crimes” for presentment to grand juries.

In closing, the letter states:

“I am available to answer your questions, IMMEDIATELY and under oath. Meantime, I will furnish this letter to the lawsuit's defendants – and to press not named in the lawsuit – so that they can report, accordingly and speedily, to NY voters who they have *knowingly* and deliberately kept 'in the dark', totally, about Attorney General James' corrupting of her office and what has been going on. (capitalization, italics, and underlining in the original).

That is what I am now doing – and I take the opportunity to bring to your attention, in particular, my [April 18th e-mail to you](#), quoted at pages 37-38 of the October 8th verified complaint. Referring to [CJA v. JCOPE, et al.](#) and [CJA v. Commission on Legislative, Judicial and Executive Compensation...Wilson, Zayas, et al.](#), then both at the New York Court of Appeals, as

“the two monumental appeals of right, brought on behalf of the People of the State of New York & the Public Interest’, whose records – like that of [CJA v. Cuomo...DiFiore](#) preceding them – establish CJA’s open-and-shut, prima facie entitlement to summary judgment on ALL causes of action, **bringing down the ENTIRETY of the state budget and the ‘false instrument’ salary increases it embeds”**,

the April 18th e-mail asked – without response from you:

“When will you be reporting on these **three fully-documented cases whose records are a ‘perfect paper trail’ of ‘false filings’ by AG Letitia James, rewarded by fraudulent judicial decisions, utterly corrupting state governance and so profoundly injuring New York’s 20 million people.**” (hyperlinking, underlining and bold in the original).

To make it easier for you, why don’t you just report on [CJA v. JCOPE, et al.](#) and [CJA v. Commission on Legislative, Judicial and Executive Compensation...Wilson, Zayas, et al.](#), to which **James is a named defendant, Hochul is a named defendant, and whose named defendant Assembly are its 150 members that include Mamdani.** These are the two lawsuits referred-to and linked by my [March 14th e-mail to Mamdani](#) entitled “ELECTIONS ARE A TIME OF ACCOUNTABILITY...”. To get you started, here are the respective [June 6, 2022 verified petition/complaint](#) and [March 18, 2024 verified petition/complaint](#).

As I have received no response from you to my [October 8th](#) and [October 12th](#) e-mails furnishing you with the verified complaint in *CJA, et al. v. LCA, et al.* – the latter expressly alerting you to “**your financial and criminal liability flowing therefrom**” – I take this opportunity to also bring that to your attention and to request that you forward this e-mail to your LCA counsel and to the legal counsel and editorial and managerial levels of your separate press entities, especially if you intend to ignore it, as well.
