## TO: Sara DiBernardo/Counsel to Senator James Skoufis

This follows up our phone conversation two days ago, on Wednesday, January 29, 2020, in which you stated that the matters I had presented last year for investigation by Senator Skoufis and the Senate

Committee on Investigations and Government Operations he chairs were "not within the jurisdiction" of the Committee and that you "couldn't substantiate" them.

As these are outright lies – obvious from the most cursory examination of my four e-mails to Chairman Skoufis and the Committee, dated January 10, 2019, January 22, 2019, January 24, 2019, and March 4, 2019 – I repeatedly urged you to review them with me, as we spoke, from CJA's webpage posting them: <a href="http://www.judgewatch.org/web-pages/searching-nys/2019-legislative/2019-senate-comm-investig-govt-ops.htm">http://www.judgewatch.org/web-pages/searching-nys/2019-legislative/2019-senate-comm-investig-govt-ops.htm</a>. You declined.

Our conversation was interrupted because you had a 3 pm meeting. Yesterday, at about 3:45 pm, I called back to speak with you, leaving a voice message at the Albany office (518-455-3290). I then called the Newburg office (845-567-1270) and left a message with Juanita. At Juanita's suggestion, I then called the Rockland office (845-786-6710) to speak with Elisha, the Legislative Director. As I recollect, no one picked up. Today, at about noon, I called the Newburg office again – and spoke with Chris, who suggested that I e-mail you.

As I stated to Chris and Juanita, I am following up with you, as a courtesy, to give you an opportunity to retract your falsehoods that the Committee has "no jurisdiction" with respect to the matters presented by my e-mails – and "couldn't substantiate [them]".

<u>Time is of the essence.</u> Please call me, first thing on Monday morning to discuss – beginning with the Committee's "jurisdiction" over the Legislature's *own* budget, indeed, its constitutional role, pursuant to Article VII, §1 of the New York State Constitution, as the "appropriate committee" responsible for the "itemized estimates of the financial needs" of the Senate that the Temporary Senate President is required to then certify. Suffice to say, the Legislature's uncertified budget for fiscal year 2020-2021 is even more FRAUDULENT and LARCENOUS than was its uncertified budget for the current fiscal year – and this requires IMMEDIATE INVESTIGATION BY THE COMMITTEE.

Below, with its above attachment, is my March 4, 2019 e-mail to Chairman Skoufis and the Committee focused on the Legislature's budget for this fiscal year and the Governor's combined legislative/judiciary budget bill. What were the Committee's answers to my 27 QUESTIONS concerning these – especially "QUESTIONS ##10-15 pertaining to the role of the Senate Committee on Investigations and Government Operations and of the Assembly Committee on Governmental Operations in compiling the Legislature's 'itemized estimates' of its 'financial needs' – including of all committees and legislator offices."

What is the status of your investigations of my January 10, 2019 e-mail, setting forth the "problem" of government dysfunction and corruption, affecting all three government branches – and its "solution" – which I sent to every member of the Committee on January 22<sup>nd</sup> and then supplemented, on January 24<sup>th</sup>, with an e-mail entitled "OVERSIGHT OF SENATE & ASSEMBLY LEADERSHIP – Willful Violations of Legislative Law Article 5-A and Article 5-B Rendering the 14 Joint Legislative Commissions Sham".

As a further supplement for the Committee's investigation into government operations – beginning with the Legislature's **own** operations, attached is my February 19, 2019 written testimony submitted for the Legislature's February 11, 2019 budget hearing on "local government officials/general government". It appends a list of 27 QUESTIONS about the Legislature's proposed budget for fiscal year 2019-2020 and Governor Cuomo's Legislative/Judiciary Budget Bill #S.1501/A.2001 and requests that the Legislature's fiscal committees secure answers from former Temporary Senate President Flanagan, Temporary Senate President Stewart-Cousins, and Assembly Speaker Heastie. Will the Senate Committee on Investigations and Government Operations – two of whose seven members sit on the Senate Finance Committee – endorse this request? Or will it answer the 27 QUESTIONS, on its own – and make the answers public? This would include QUESTIONS ##10-15 pertaining to the role of the Senate Committee on Investigations and Government Operations and of the Assembly Committee on Governmental Operations in compiling the Legislature's "itemized estimates" of its "financial needs" – including of all committees and legislator offices. By this e-mail, I request that such be placed on the agenda of the Committee's next meeting for discussion and vote.
