Pursuant to FOIL (Public Officers Law VI "Freedom of Information Law"), this is to request:

- (1) any written testimony/statement submitted by Inspector General Lang to the Senate Committee on Ethics and Internal Governance prior to, for, or any time since its [December 9, 2021 hearing on "New York State's system of ethics oversight and enforcement"](#);
- (2) the case numbers assigned to my above-attached November 2, 2021 complaint to Inspector General Lang, consisting of six inter-related complaints – whose receipt by the IG's office is reflected by my below November 3, 2021 e-mail and as to which I received no subsequent communication, including of disposition – including in response to my below December 7, 2021 e-mail entitled "STATUS? Protocol? -- CJA's Nov. 2, 2021 complaint to NYS Inspector General Lucy Lang -- sent Nov. 2, 2021 at 5:55 pm via website: <https://ig.ny.gov/form/complaint-form-long>";
- (3) all records pertaining to the "professional manner" in which the IG's office has handled my November 2, 2021 complaint, consistent with its [Policy and Procedure Manual \(Policy # 0101\)](#);
- (4) all records reflecting the names of the members of the "Case Review Panel" who, along with Inspector General Lang, would have been furnished with my November 2, 2021 complaint and whose discussions and determinations "as to actions to be taken" would be documented by "[t]he CMU Chief or CMU-designated staff" as an "entry into OIG's case management system", according to the IG's [Policy and Procedure Manual \(Policy # 0101\)](#);

- (5) all records reflecting whether my November 2, 2021 complaint was reported to “the secretary to the governor”, pursuant to [Executive Law §52.3](#) or otherwise;
- (6) records identifying the names of Inspector General Lang’s:

It is now over a month since I filed my FULLY-DOCUMENTED November 2, 2021 complaint – and I have received no written acknowledgment, nor assigned numbers for it. Nor have I received any phone call from any investigative staff with any questions about the complaint. The first and only phone call I received – responding to a phone message I had left -- was on November 3<sup>rd</sup>, as recounted by the below. Is this your normal and customary protocol?

My FULLY-DOCUMENTED complaint is set forth in a letter of today's date to Inspector General Lucy Lang entitled "ENABLING YOU TO FAITHFULLY DISCHARGE THE DUTIES OF YOUR OFFICE: Sworn complaints against 'covered agencies' within your jurisdiction: (1) the Office of the Inspector General; (2) the Joint Commission on Public Ethics; (3) the State University of New York; (4) the Division on the Budget; (5) the defunct Commission on Judicial Compensation, whose fraudulent August 29, 2011 report lives on, rewarding a corrupt judiciary with pay raises and depriving the public of functioning safeguards against judicial corruption; and (6) the defunct Commission to Investigate Public Corruption, whose fraudulent December 2, 2013 report lives on, concealing the manifestations and true causes of New York's corruption and the ease with which it is rectified."
