We have completed our review of your complaint against the above named attorney. As explained below, we have concluded that no investigation or action is warranted.

Specifically, you alleged that the Solicitor General of New York, Barbara Underwood, engaged in litigation fraud, corruption, and a conflict of interest based on her personal and professional relationships with AG Schneiderman, Judge Hartman, Governor Cuomo, and other supervisory and managerial attorneys. There is insufficient basis to establish that Ms. Underwood violated the New York Rules of Professional Conduct.
