**Subject:** OVERSIGHT REQUIRED: CJC's staff is REFUSING to acknowledge - & give a complaint # to - a filed, sworn Nov. 24, 2021 complaint vs CJC's 4 judge-members & REFUSES to advise as to the status of the complaint's "reconsideration" & "determination" requests

**TO: NYS Commission on Judicial Conduct Chair Joseph Belluck, ESQ.**

I am writing you, directly, because I have received NO acknowledgment or response to my above-attached November 24, 2021 complaint against the Commission's four judge-members for participating in the Commission's alleged dismissal of [my February 7, 2021 complaint](#) in which three of the four judge-members – Appellate Division Justice Angela Mazzarelli, Appellate Division Justice Robert Miller, and Acting Supreme Court Justice/Court of Claims Judge Fernando Camacho – had direct financial interests – and the fourth, Brighton Town Court Justice John Falk, possibly indirect financial interests.

Are you aware of my November 24, 2021 complaint – and that NO “acknowledgment letter” has been sent to me by Commission staff, either by postal mail or by e-mail?

[On January 18, 2022](#), I e-mailed the Commission that I had received NO “acknowledgment letter” and further asked: “BTW, did you assign a single complaint number to the complaint or four separate complaint numbers – one for each of the four complained-against judges?”. I also inquired “as to the status of the other relief requested by my November 24, 2021 complaint letter: ‘(1) Reconsideration of the Commission's dismissal of [my] February 7, 2021 judicial misconduct complaint, as provided for by the Commission's Policy Manual §2.12; and (2) Determination of [my] April 26, 2021 ‘further and supplementing complaint’, consistent with the Commission's Policy Manual §2.1.” I received NO response – and, [on February 25, 2022](#), so-stated in a further e-mail to the Commission, requesting, in bold, a prompt response by e-mail. I have received NO response.

Perhaps you are also unaware of the original February 7, 2021 complaint – and of the [April 26, 2021 “further and supplementing complaint”](#). If so, that would explain why Commission staff has seemingly not assigned complaint numbers to my November 24, 2021 complaint. In any event, Commission staff may be presumed to recognize that my November 24, 2021 complaint constitutes grounds for any properly-functioning Commission to remove Administrator/Counsel Robert Tembeckjian, Clerk Celia Zahner, ESQ., and other staff complicit with them, pursuant to [Judiciary Law §41.7](#) and [22 NYCRR §7000.13](#), as it EVIDENTIARILY establishes their conflicts of interest, misconduct, and fraud in the performance of their duties. Indeed, **the ONLY open question presented by the November 24, 2021 complaint is the extent to which the Commission's eleven *unsalaried* members – in trusting reliance on *salaried* staff – have been manipulated to completely violate their constitutional, statutory, and ethical duties – and the Commission's own policy manual.**

Although you are the Commission's chair, elected by its members (Judiciary Law §41.2), ALL eleven members are responsible for the Commission's proper functioning. Consequently, I am cc'ing Commission members Ronald Rosenberg, ESQ., Graham Seiter, ESQ., Marvin Ray Raskin, ESQ., and Jodie Corngold, whose e-mail addresses I have, so that they can ensure that this e-mail is forwarded to the Commission's two other non-judge members, Vice Chair Taa Grays, ESQ. and Akosua Garcia Yeboah, and to the Commission's four judge-members, if deemed appropriate notwithstanding Policy Manual Rule 5.3(A) – and that an EMERGENCY meeting be called to discuss and determine the November 24, 2021 complaint. Of course, threshold must be discussion of financial and other conflicts of interest and bias-inducing relationships of the Commission members – and in that regard my November 24, 2021 complaint presents BOTH operative law and relevant facts.

Below are my January 18, 2022 and February 25, 2022 e-mails to the Commission – and beneath them my November 24, 2021 e-mail transmitting the complaint.
