The matters that you raised with respect to Judge Shollenberger, which have been featured in local newspapers, have already been brought to the attention of the Commission.

The second email, which you transmitted to the Commission on June 26, 2017 at 1:19 p.m., relates to your complaint against Judge McCullough. As the Commission's jurisdiction is limited to judges of the Unified Court System and Judge McCullough is no longer a judge of the Unified Court System as a result of his resignation from judicial office, the Commission is without jurisdiction to pursue your complaint.

We apologize for any confusion caused by our letter of July 25, 2017, which related only to your complaint against former Judge McCullough.
