CJA's Three Litigations whose Records are Perfect 'Paper Trails' for Indicting New York's Highest Public Officers for Corruption"; (3) "Assisting U.S. Attorney Bharara Live Up To His Rhetoric" -- and, the most recent "Putting an End to 'Fake News'".
