The Suffolk County party bosses are colluding to install NYS Senator Phil Boyle as Suffolk County sheriff. In addition to the Republican line, he has the Conservative and Independence party lines. Running against him, in the Republican primary on September 12th, is Larry Zacarese, who, unlike Boyle, is seemingly NOT a party hack, has law enforcement credentials, and, for that reason, was endorsed by the Reform Party.
