But there is MORE! The December 24, 2015 report on which the current round of D.A. pay raises rest is a "false instrument" – statutorily-violative, fraudulent, and unconstitutional. The Albany Legislators, from Suffolk County – as, for instance, Boyle – have knowingly and deliberately failed to discharge their oversight responsibilities to override its judicial pay raise recommendations. This is what I testified about on January 30, 2017, in Albany, at the Senate-Assembly budget hearing on "local government officials/general government" at which lawyer-Senator Boyle should have been present, but was not – notwithstanding my January 26, 2017 email to him and to EVERY other member of the Senate Committee on Local Government. However, present was Senator Brooks – who, incredibly, has now been elevated to Ranking Member of the Senate Committee on Local Gov't, of which Boyle is a member – replacing lawyer-Senator Kaminsky, who, incredibly, had been elevated to that position, upon his special-election to the Senate in 2016.

Sitting next to Senator Brooks, during my January 30, 2017 testimony, was Senator Marchione, who chairs the Senate Committee on Local Government. Did they each think they had NO obligation to apprise the membership of the Senate Committee on Local Government of my testimony with respect to the D.A. salary-reimbursement issue – as to which, on February 8, 2017, I sent a follow-up e-mail to Marchione & Kaminsky. Was Boyle apprised of NONE of this by his Senate colleagues – including Senate Majority Leader Flanagan, to whom I addressed my February 6, 2017 letter pertaining to my testimony and CJA's citizen-taxpayer action?

Boyle and Kaminsky are lawyers, as is Flanagan. Shouldn't Suffolk County Legislator Lindsey be able to turn to them — and the many other Senate & Assembly lawyer-legislators for findings of fact and conclusions of law with respect to the state of the record in CJA's citizen-taxpayer action? Hi, Elena -

Excellent progress! Let me revisit the issue of the Suffolk DA's salary. The County Legislature can make a persuasive argument TO THE STATE DELEGATION IN ALBANY that they want the state law changed so as to return to local control the salary structure of its locally elected DA. Given that the Suffolk's incumbent DA is not running for reelection, leaving the position open to the results of the November election, there is not even the appearance of any punitive motive that might be ascribed to this effort.

It will take some research on the legislators' part to understand the genesis of this relinquishment of home rule back in 1980, but they will see from the minutes of meetings back then, if they have been preserved, that there were objections quite substantive in the context of today's fiscal crisis.
