I am director and co-founder of a non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc. (CJA). This e-mail follows my phone call this morning to <u>The Daily Orange</u> in response to the October 20th article of Marnia Munoz "<u>District attorney incumbent challanged for first time in over 10 years</u>" – and my lengthy conversation with Erica Morrison, a Newhouse student who works on the business side of the <u>Daily Orange</u>'s operations.

As I showed Ms. Morrison, CJA's homepage, www.judgewatch.org, contains a prominent center link "Elections - 2019", which leads to a menu page for the Onondaga County elections for district attorney – involving incumbent D.A.

Fitzpatrick – and for Supreme Court justices for the 5th Judicial District – involving Onondaga state Senator Antonacci. It is imperative that there be investigation and reporting of the readily-verifiable EVIDENCE of the public corruption of Fitzpatrick and Antonacci – and what has been going on with respect to their electoral races. For the past nearly two weeks, I have tried to get the assistance of professors of Syracuse University's Newhouse School of Public Communications, of its Maxwell School of Citizenship and Public Affairs, and of its Institute for the Study of the Judiciary, Politics, and the Media – to no avail. Indeed, not a single Syracuse University professor saw fit to alert me to the
