John Flynn is "sitting on" CJA's June 12, 2020 public corruption/grand jury complaint against Erie County state legislators and running for re-election, unopposed, on the lines of ALL eight of New York's recognized parties Democratic, Republican, Independence, Conservative, Working Families, Green, Libertarian, and Serve America Movement (SAM), as to which he faced no primary challenge;
