RE: Your two articles by Jon Levine, both published on your website yesterday, March 27, 2021:

"Tensions emerge among lawmakers of color over Gov. Cuomo's fate" (at 1:44 pm); and "John Catsimatidis' family divided over Republican NYC mayoral primary" (at 12:33 pm)

NY's "lawmakers of color" -- beginning with the highest -- Andrea Stewart-Cousins -- and NY's attorney general "of color" -- Letitia James -- cannot "fill the coming power void in Albany" because they must be removed from office, *with* Governor Cuomo, *with* Lieutenant Governor Hochul, *with* Comptroller DiNapoli, and *with* NY's less-"color[ed]" and white lawmakers because ALL are collusive *with* the Governor in the corruption of state governance involving their pay raises and the state budget. This -- and the collusion of NY's judges -- from Chief Judge Janet DiFiore and her six Court of Appeals colleagues, on down -- are detailed by a FULLY-DOCUMENTED June 4, 2020 grand jury/public corruption complaint, filed with Albany's DA "of color" -- P. David Soares -- who, rather than do his duty, advised that "the appropriate entities to investigate" are the Joint Commission on Public Ethics (JCOPE) and the Legislative Ethics Commission (LEC). Based thereon, a March 5, 2021 complaint was filed with JCOPE and LEC - expanded to include the happening-now FY2021-22 state budget and the newbie state legislators elected in November 2020 and reinforced, as to AG James, by a February 11, 2021 complaint against her, filed with NY's attorney grievance committees, and its accompanying February 7, 2021 complaint against the judges, filed with the Commission on Judicial Conduct, both supplied.

Please bump this up to your highest editors and management, including <u>Post</u> Publisher/CEO Sean Giancola, New York Post Group Editor-in-Chief Keith Poole, and News Corp CEO Robert Thomson, if you do not plan to seize this LEAD — and restore for ALL the People of the State of New York, by your reporting, some actuality of constitutional, accountable governance, rather than reporting falsehoods of self-interested and corrupt public officers and those involved with them.

I am available to be interviewed and to assist you, to the max. Indeed, here's a further LEAD, thus far furnished to only one other publication, the philanthropically and member-supported The City, which touts itself as "a nonprofit, nonpartisan digital news platform dedicated to hard-hitting reporting that serves the people of New York, producing consistent, high-quality and high-impact accountability reporting", to wit, that this story of pay raises and the state budget "impacts, DIRECTLY, on key New York City Democratic primary races – tantamount to election". As illustrative, it knocks out – with open-and-shut, prima facie EVIDENCE – (1) Would-Be NYC Mayors Scott Stringer and Eric Adams; (2) Would-Be NYC Comptrollers Brian Benjamin, David Weprin, ESQ, and Kevin Parker; (3) Would-Be Manhattan Borough

Presidents Brad Hoylman, ESQ. and Ben Kallos; and (4) Would-Be Manhattan District Attorneys Dan Quart, ESQ. and Alvin Bragg, ESQ.. It also throws open, to Democratic primary challengers, the race for Brooklyn district attorney against incumbent Eric Gonzalez, who it knocks out — and makes competitive the Democratic primary for New York City public advocate against incumbent Jumaane Williams, who it knocks out.
