The duty of the Herkimer County D.A. is to enforce New York's penal laws and obey conflict of interest protocols. That is the subject of the Center for Judicial Accountability's above-attached July 18, 2024 grand jury/public corruption complaint to Herkimer County D.A. Carpenter, sent to him by the below e-mail. It involves his \$221,100 D.A. salary – statutorily-linked to the Herkimer county court judge salary – \$101,300 of which is the product of three “false instrument”, penal law-violating commission reports, of which Herkimer County's four state legislators – Griffo, Walczyk, Smullen, and Miller – each running for re-election, are knowledgeable and complicit.

D.A. Carpenter is himself running for re-election unopposed, on the Republican and Conservative lines, for which he faced no primary challenge on either line. I received no response from him to the July 18, 2024 grand jury/public corruption complaint, which requested his response by August 1, 2024 to two simple questions:

- (1) whether he would be repudiating the \$101,300 salary difference and advising Herkimer County to secure a judicial declaration voiding the three “false instrument”, penal law-violating commission reports?;
- (2) whether he would be recusing himself from the July 18, 2024 grand jury/public corruption complaint and securing an independent prosecutor?

As D.A. Carpenter will surely be more responsive to inquiries from the Observer Dispatch, I am cc'ing him.

Please call me so that we can discuss these two questions and your election reporting and editorializing about Herkimer County's D.A. race, state legislative races, and judicial races – all involving “false instrument”, penal law-violating salaries for these offices.
