The link at page 10 to "Institute of Journalism & 'Media Scholarship" has links to webpages of my correspondence, in 2006-2007, with Harvard University's Shorenstein Center on Media, Politics & Public Policy of its Kennedy School of Government and with Harvard University's Nieman Foundation for Journalism, including with regard to the cause of action for "journalistic fraud", proposed as viable under the First Amendment and as waiting to be tested, by the 2003 law review article "Journalistic Malpractice: Suing Jayson Blair and the New York Times for Fraud and Negligence" — and which I was then testing by a first-of-its-kind lawsuit against The Times for its knowingly false, corruption-abetting, election-rigging journalism, including its fraudulent November 2004 article about me, while I was incarcerated in D.C. on the bogus "disruption of Congress" charge.

This follows your excellent column in today's New York Post "<u>Tish James will eat her own words</u>" that "No one is above the law" – and my <u>April 1<sup>st</sup></u> & <u>April 2<sup>nd</sup></u> e-mails to you pertaining to my above-attached February 18<sup>th</sup> letter to House DOGE Subcommittee Chair Marjorie Taylor Greene and Federal Communications Commission Chair Brendan Carr entitled "Defunding NPR, PBS -- & Firing the CPB's Inspector General, for starters".

As stated by my February 18<sup>th</sup> letter (at pp. 6-8), years ago, I tried to alert the then former President Trump that AG James – while going after him because "No one is above the law" – was herself "above the law", corrupting the judicial process by litigation fraud to defeat major lawsuits against NYS' highest constitutional officers, herself among them, for unconstitutional, unlawful, larcenous state governance involving the entire state budget and pay raises, including her own, protected by NYS courts, NYS ethics and criminal authorities, federal criminal authorities, and the NYS press – and that I had constructed, for that purpose, two webpages on CJA's website. At last week's March 26<sup>th</sup> DOGE Subcommittee hearing "Anti-American Airwaves: Holding the Heads of NPR and PBS Accountable", Subcommittee Chair Greene did not reveal that Ranking Member Stansbury was absent – and neither you nor anyone else at the hearing made any mention of my above-attached February 18<sup>th</sup> letter "Defunding NPR, PBS – & Firing the CPB's Inspector General, for starters". ## Please advise:

- whether the "flash drive containing six feet worth of documents documenting NPR and PBS' political bias" that, at the hearing, you asked to "submit to the record" "with unanimous consent" and that Chair Greene "without objection, so-ordered" (at 2hrs/25 mins), included my February 18<sup>th</sup> letter, which I had repeatedly requested be made part of the record;
- whether, in response to Chair Greene's concluding announcement that "all members have five legislative days within which to submit materials and additional written questions for witnesses, which will be forwarded to the witnesses" (at 2 hrs/40 mins), you will be explicitly requesting responses from Presidents Maher and Kerger to my February 18<sup>th</sup> letter and submitting the letter for the record, if you have not already done so.

## Behind-the-Scenes of Tomorrow's House DOGE Subcommittee Hearing on NPR & PBS Bias

Why are the NPR and PBS presidents the only witnesses scheduled to testify at Wednesday's DOGE Subcommittee hearing on NPR and PBS bias?
