I am director and co-founder of the national, non-partisan, non-profit citizens' organization, <u>Center for</u> <u>Judicial Accountability, Inc. (CJA)</u>, based in New York – and for the past six weeks, since I sent the aboveattached February 18<sup>th</sup> letter to House DOGE Subcommittee Chair Marjorie Taylor Greene and Federal Communications Commission Chair Brendan Carr, entitled "Defunding NPR, PBS – & Firing the CPB's Inspector General, for starter", have been <u>a behind-the-scenes participant in what has been unfolding</u>.

The February 18<sup>th</sup> letter chronicles "knowingly false, corruption-abetting, election-rigging journalism" by NPR and PBS' local New York affiliates – the subject of fully-documented complaints to the NPR and PBS national entities, <u>ignored</u>, without response, by their public editors, presidents, boards of directors, and counsel and which the Corporation for Public Broadcasting's Inspector General thereafter also <u>ignored</u>, without response. The letter is explosive for that reason, but also because it identifies that NPR's and PBS' "knowingly false, corruption-abetting, election-rigging" New York "local journalism" is NOT unique to them, but is how the gamut of New York's "local journalism" operates, from <u>The New York Times</u> on down. This includes – and the letter highlights – the 2018 election and 2022 re-election of Letitia James as New York attorney general and the 2021 election of Alvin Bragg as Manhattan district attorney, each pivotally responsible for the corruption and unconstitutionality of New York state governance involving the massive, policy-filled, larcenous state budget and the "false instrument" pay raises for public officers it embeds, concealed, *in toto*, by New York's press so as to enable these two corrupt posturers to invidiously and selectively prosecute Mr. Trump on rhetoric that "no one is above the law".

Prior to the March 26<sup>th</sup> DOGE Subcommittee hearing "Anti-American Airwaves: Holding the Heads of NPR and PBS Accountable", I furnished the February 18<sup>th</sup> letter to a large swath of press, including to the very journalists who would thereafter report on the hearing and conceal it, totally.

CJA's website, <u>www.judgewatch.org</u>, posts everything, accessible from an evidentiary webpage, <u>here</u>. It posts the span of my e-mails transmitting the February 18<sup>th</sup> letter to Subcommittee Chair Greene, *c/o* the majority office of the House Committee on Oversight and Government Reform, to FCC Chair Carr, to DOGE Subcommittee Ranking Member Melanie Stansbury, to Rank-and-File Member Brandon Gill, and to NPR and PBS. The last is my below March 31<sup>st</sup> e-mail to Congressman Gill entitled "Questions about & for the Record of the March 26<sup>th</sup> DOGE Subcommittee Hearing..." – and it was preceded by my <u>March 28<sup>th</sup> e-mail</u> to Subcommittee Ranking Member Stansbury, inquiring about her absence from the March 26<sup>th</sup> hearing.

As for my outreach to the press about the February 18<sup>th</sup> letter and what has been going on, here's its <u>webpage</u> – and from it you can draw your own conclusions about press performance, including by NPR and <u>The New York Times</u>. Additionally noteworthy is the sequence of my e-mails to the journalism faculty of Hillsdale College and its journalist alum Casey Harper and then to its Senior Journalism Fellow Mollie Hemingway, my e-mail to <u>Columbia Journalism Review</u> that included the dean of the J-School and Margaret Sullivan, the executive director of its Craig Newmark Center for Journalism Ethics, my sequence of e-mails to <u>The Free Press</u> and, specifically, Uri Berliner and Bari Weiss, and the e-mails I sent to so many e-mail addresses at <u>The Washington Post</u>.

Can our democracy endure when this is how Congress and the press operate? And where are the scholars whose scholarship is based on evidence that is not cherry-picked to conform to their partisan and ideological agendas? What can you do to help? Will you publicize – and bring into scholarship – this primary-source, documentary evidence – and, if not, will you forward it to others who will?

Subject: Questions about & for the Record of the March 26th DOGE Subcommittee Hearing "Anti-American Airwaves: Holding the Heads of NPR and PBS Accountable"

TO: House DOGE Subcommittee Rank-and-File Member Brandon Gill

At last week's <u>March 26<sup>th</sup> DOGE Subcommittee hearing "Anti-American Airwaves: Holding the Heads of</u> <u>NPR and PBS Accountable</u>", Subcommittee Chair Greene did not reveal that Ranking Member Stansbury was absent – and neither you nor anyone else at the hearing made any mention of my above-attached February 18<sup>th</sup> letter "Defunding NPR, PBS – & Firing the CPB's Inspector General, for starters". The letter, which by the below March 25<sup>th</sup> e-mails I sent first to Ranking Member Stansbury and then to you, requested that each of you ensure that it was furnished to all Subcommittee members – and I followed this with two further e-mails to you confirming my transmittal of the letter to NPR Presidents Maher and Kerger so that they would be ready for questioning about it at the hearing, <u>here</u> and <u>here</u>.

Please advise:

- whether, as my March 25<sup>th</sup> e-mail to you requested, you forwarded my <u>February 18th</u> <u>letter</u> to "all DOGE Subcommittee members";
- whether the "flash drive containing six feet worth of documents documenting NPR and PBS' political bias" that, at the hearing, you asked to "submit to the record" "with unanimous consent" and that Chair Greene "without objection, so-ordered" (at 2hrs/25 mins), included my February 18<sup>th</sup> letter, which I had repeatedly requested be made part of the record;
- whether, in response to Chair Greene's concluding announcement that "all members have five legislative days within which to submit materials and additional written questions for witnesses, which will be forwarded to the witnesses" (at 2 hrs/40 mins), you will be explicitly requesting responses from Presidents Maher and Kerger to my February 18<sup>th</sup> letter – and submitting the letter for the record, if you have not already done so.

Suffice to add that Presidents Maher and Kerger, both by their oral testimony and written statements, <u>here</u> and <u>here</u>, made no mention of their respective NPR and PBS public editors, whose importance my February 18<sup>th</sup> letter highlights – and this is additionally telling as the <u>written statement</u> that President Maher submitted for last year's <u>May 8, 2024 hearing "*Examining Accusations of Ideological Bias at NPR*" of the Subcommittee on Oversight and Investigations of the House Committee on Energy and Commerce, at which, in her absence, she sent no one in her stead, such as, most reasonably, the NPR public editor, had stated:</u>

"NPR is one of the only journalistic institutions in the country with a Public Editor. The public editor is a source of independent accountability who serves as an advocate for NPR listeners and readers, with complete autonomy to investigate complaints, address the quality of NPR journalism, and transparently share findings with the public." (at p. 3).

## Behind-the-Scenes of Tomorrow's House DOGE Subcommittee Hearing on NPR & PBS Bias

Why are the NPR and PBS presidents <u>the only witnesses scheduled to testify at Wednesday's DOGE</u> <u>Subcommittee hearing on NPR and PBS bias</u>? What about the NPR and PBS public editors, each responsible for complaints, and the Corporation for Public Broadcasting's Inspector General, also responsible for complaints. And what about complainants who have filed complaints with all of them?

The importance of this was the subject of my above-attached <u>February 18<sup>th</sup> letter</u> to DOGE Subcommittee Chair Marjorie Taylor Greene and FCC Chair Brendan Carr entitled "Defunding NPR, PBS – & Firing the CPB's Inspector General, for starters". It opened with these two sentences:

"I am director and co-founder of the New York-based non-partisan, non-profit citizens' organization <u>Center for Judicial Accountability</u>, Inc. (CJA) and applaud your efforts to expose the truth about NPR and PBS.<sup>fn1</sup> I suggest you do so by examining how they handle complaints of biased and *knowingly* false journalism – and that you also examine how the Corporation for Public Broadcasting's Inspector General handles complaints about NPR's and PBS' handling of complaints." (italics in the original).

Nine EVIDENCE-FILLED pages later— including as to the collusion of NPR, PBS, and other media in the corruption of New York state governance involving its massive, policy-filled state budget, pay raises, NY Attorney General Letitia James, and NY District Attorney Alvin Bragg – the letter concluded, stating:

"I am available to answer questions – including under oath. I would be honored to testify at such hearings as you will be holding. In any event, I ask that this statement be submitted for the record of the hearings. I affirm it all to be true, under penalties of perjury. Kindly forward the letter to all who are committed to establishing the truth about NPR, PBS, and their collusion with other media in 'election interference' and other violations of First Amendment responsibilities. There is much defunding, firing, and prosecutions that need to take place.<sup>fn8</sup>"

Three times I e-mailed the letter to the majority office of the House Committee on Oversight and Government Reform and to FCC Chair Carr – <u>February 18<sup>th</sup></u>, <u>February 28<sup>th</sup></u>, and <u>March 19<sup>th</sup></u> – *without response*. # Subject: Defunding NPR, PBS - & Firing the CPB's Inspector General, for starters

TO: House DOGE Subcommittee Chair Marjorie Taylor Greene (Delivering on Government Efficiency) Federal Communications Commission Chair Brendan Carr

Attached is my letter of today's date addressed to you, furnishing a mountain of evidence for defunding NPR and PBS, which their presidents will <u>not</u> be able to defend against at your <u>upcoming March</u> <u>hearing</u>. Likewise, for firing the Corporation for Public Broadcasting's Inspector General and her deputy and counsel, who will <u>not</u> be able to defend against the evidence the letter presents.

To afford you sufficient time to review the letter and make strategic decisions about when to forward it to the NPR and PBS presidents so that they can prepare themselves for questioning about it and, additionally, about requiring the NPR and PBS public editors to also testify at the hearing, with statistics as to the number of complaints they receive of biased, corruption-abetting, election-rigging, fraudulent journalism and how they handle them, indeed, whether you might want to issue subpoenas for their records, I will withhold sending my letter to them, or disseminating and publicizing it until I hear from you.

"...please forward this letter to U.S. Attorney General Pam Bondi, as it will greatly assist her investigations of A.G. James and D.A. Bragg, reported by [New York Public News Network reporter] Han's February 6, 2025 article "<u>U.S. Attorney General vows to</u> *investigate two of New York's top lawyers*", to which I cited and linked by <u>my February 7,</u> <u>2025 e-mail</u> to her entitled "A gift to welcome you to your new job, as a Capitol News Bureau reporter for the NY Public News Network – Explosive evidence, complete unreported, about the state budget, A.G. James, & D.A. Bragg".

I would appreciate if you will do this, as I know it will reach her more directly than my own efforts.
