In keeping with these and so many other columns you have posted, here's some unreported news for your examination and blogging: [The New York Times](#) and other press rigged Zohran Mamdani's electoral win as NYC mayor, just as they rigged the electoral wins of Letitia James to be NY Attorney General, Alvin Bragg to be Manhattan D.A., and, for years, rigged essentially all NY's top electoral and appointive offices – and this is the subject a major federal lawsuit, brought "*on behalf of the People of the State of New York & the Public Interest*", suing the [NYT](#) and 33 other press entities for their *knowingly* false, corruption-abetting, election-rigging journalism, destroying constitutional, lawful NYS governance and seeking judicial recognition of causes of action for "journalistic fraud" and "institutional reckless disregard for truth".

Above-attached and here-linked is the [October 29, 2025 amended verified complaint](#), whose prefacing quote reads:

"The First Amendment goes beyond protection of the press...'it is the right of the [public], not the right of the [media], which is paramount,'...for 'without the information

provided by the press most of us and many of our representatives would be unable to vote intelligently or to register opinions on the administration of government generally,'..."

Cohen v. Cowles Media Co., 501 U.S. 663, 678 (1991), Justice Souter, writing in dissent with Justices Marshall, Blackmun, and O'Connor, citing cases culminating in *New York Times Co. v. Sullivan*, 376 U.S. 254, 278-279 (1964), cited in "*Journalistic Malpractice: Suing Jayson Blair and the New York Times for Fraud and Negligence*", 14 Fordham Intellectual Property, Media & Entertainment Law Journal 1, footnotes 62 and 156 (2003).^{fn}
