Mamdani's win as NYC mayor was rigged by The New York Times & other press – and this is the subject of a major federal lawsuit.

The federal lawsuit, brought “*on behalf of the People of the State of New York & the Public Interest*” by the nonpartisan, nonprofit citizens’ organization [Center for Judicial Accountability, Inc. \(CJA\)](#), of which I am director and co-founder, is against The New York Times and 33 other press defendants. Here-linked is the [October 29, 2025 verified amended complaint](#), furnishing all the particulars, with hyperlinks to the open-and-shut, *prima facie* evidence. This includes my [March 14, 2025 e-mail to Mamdani](#) entitled “ELECTIONS ARE A TIME OF ACCOUNTABILITY...”, then supplemented by my [March 17th e-mail to him](#), both of which I furnished to Mamdani again when I cc’d him on my [March 18th](#) and [March 20th](#) e-mails to the press. He responded to none of them. Nor did the press – and among my other e-mails to the NYT are my [July 11th e-mail](#), my [July 13th e-mail](#), my [August 9th e-mail](#), and my [September 18th e-mail](#).

Lawyers and legal scholars on whom you rely for expert opinion should be able to confirm for you what will be obvious from your examination of the verified amended complaint, namely, that there is NO defense to it, factually or legally – and that the SOLE issue will be the magnitude of compensatory, presumed, and punitive damages, a jury determination that will reasonably be many billions of dollars. The district court's unprecedented handling of the case – as reflected by my [December 19th affidavit](#) and [February 23rd letter to the judge](#) and his [March 2nd so-ordered annotation](#) – reinforces this.

Will you report on the lawsuit – or forward this message to journalists who will?
