I have had no response to my September 20, 1994 letter nor any confirmation of my reinstatement to membership.


As you know, I telephoned you shortly after the meeting to learn At that time, you reported to me that the Board "had voted to take no action" on my letter. about the names of the Board present and voting at the meeting, When I inquired you refused to disclose them to me. Nor would you tell me the names of the whole Board, whether or not present and voting at the meeting at which such deliberate inaction was voted.

You further indicated that "the Board" had prohibited disclosure of that information, and, moreover, had not authorized any letter

wish to record my vigorous protest to such disreputable behavior -- which, in view of my September 20, 1994 letter, is all

Since that letter, the Court of Appeals has denied review of my Article 78 proceeding, either by right or by leave to appeal. Consequently, I will be seeking review from the U.S. Supreme Court by a petition for certiorari.

It is my fervent hope that the Westchester Bar Association will not be guilty of continued indifference to the obliteration of my civil rights, detailed in my prior letter. the film "Judgment at Nuremberg", fifty years ago lawyers and judges, charged with upholding the law, nonetheless stood by and



To date, this organization has stood mutely by while a member lawyer has been suspended, without any hearing, under a findingless suspension order that, on its face, is unlawful. Nor has this organization reacted to the egregious violation of law and fundamental ethical rules in my Article 78 proceeding, where the very judges I charged with issuing and perpetuating a knowingly fraudulent and retaliatory suspension of my license, refused to recuse themselves from their own case and, predictably, decided it in their own favor.

Please provide me with the names and numbers of the Chairs of those Committees of the Westchester Bar, which are involved in issues of professional responsibility--and to whom I can make a direct presentation.

Also, kindly furnish me with a copy of the Charter and By-Laws of the Westchester Bar Association and confirm the restoration of my membership without further delay.
