(1) CJA's March 3, 2000 letter to Chief Judge Judith Kaye¹, transmitting to her a copy of the file in *Elena Ruth Sassower v. Commission*, including its physically-incorporated copies of the files of *Doris L. Sassower v. Commission* (NY Co. #95-109141) and *Michael Mantell v. Commission* (NY Co. #99-108655) and requesting (at p. 2), *inter alia*, that she appoint a Special Inspector General to investigate the corruption of the New York State Commission on Judicial Conduct and the subversion of the judicial process by the State Attorney General and judges of Supreme Court/New York County in these three Article 78 proceedings, of which the Commission is the *direct* beneficiary;

(2) CJA's March 3, 2000 letter to the Commission on Judicial Conduct, constituting a judicial misconduct complaint against Acting Supreme Court Justice William Wetzel and Administrative Judge Stephen Crane for official misconduct in *Elena Ruth Sassower v. Commission*, of which the Commission is the *direct* beneficiary, AND calling upon it (at pp. 3-4), by reason of its conflict of interest, to take steps to ensure that the complaint is *independently* determined;




